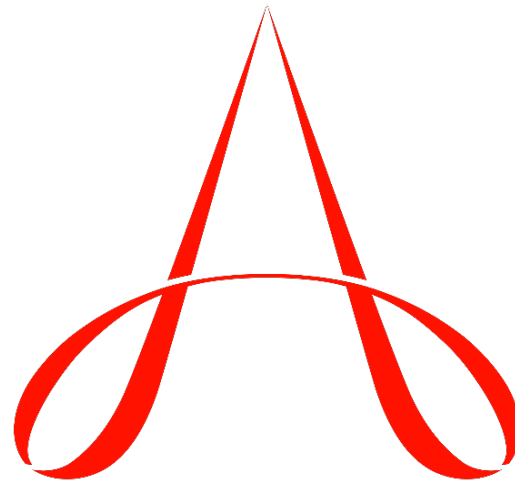

## **Milestones Supplemental Guide**

This document provides additional guidance and examples for the Clinical Biochemical Genetics Milestones. This is not designed to indicate any specific requirements for each level, but to provide insight into the thinking of the Milestone Work Group.

Included in this document is the intent of each Milestone and examples of what a Clinical Competency Committee (CCC) might expect to be observed/assessed at each level. Also included are suggested assessment models and tools for each subcompetency, references, and other useful information.

Review this guide with the CCC and faculty members. As the program develops a shared mental model of the Milestones, consider creating an individualized guide (Supplemental Guide Template available) with institution/program-specific examples, assessment tools used by the program, and curricular components.

**Patient Care 1: Pre-Analytic**

**Overall Intent:** To ensure the fellow can identify appropriate specimens for testing and methods of collection, storage, and transport

<p><b>Level 2</b> <i>Gathers pertinent elements of the clinical history to aid in test selection</i></p> <p><i>Recognizes sources of pre-analytic error</i></p> <p><i>Describes rationale behind existing routine laboratory workflows</i></p>	<ul style="list-style-type: none"> <li>● Locates pertinent clinical information required for testing using the electronic health record (EHR)</li> <li>● Identifies that test results may be compromised if the specimen is collected in an inappropriate collection container</li> <li>● Recognizes that testing schedules can be modified to accommodate courier delays</li> </ul>
<p><b>Level 3</b> <i>Recommends the optimal test option(s) based on clinical or family history, with assistance</i></p> <p><i>Evaluates a specimen for pre-analytic errors, with assistance</i></p> <p><i>Suggests modifications to existing laboratory workflows based on clinical need, with assistance</i></p>	<ul style="list-style-type: none"> <li>● Recommends urine organic acid testing for a patient with metabolic acidosis and hyperammonemia</li> <li>● Recognizes that a referring laboratory frequently sends specimens of insufficient quantity and contacts send-out staff to discuss</li> <li>● Proposes a new workflow for short turnaround time (STAT) specimens</li> <li>● Suggests adding another testing batch to the weekly schedule to accommodate an increase in test volume</li> </ul>
<p><b>Level 4</b> <i>Independently recommends the optimal test(s) based on clinical or family history</i></p> <p><i>Independently evaluates a specimen for pre-analytic errors and identifies possible resolutions</i></p> <p><i>Independently suggests modifications to existing laboratory workflows based on clinical need</i></p>	<ul style="list-style-type: none"> <li>● Recommends urine organic acid testing for a patient with metabolic acidosis and hyperammonemia</li> <li>● Recognizes that a referring laboratory frequently sends samples of insufficiency quantity and, working with laboratory supervisor, contacts send-out staff to discuss</li> <li>● Suggests adding another testing batch to the weekly schedule to accommodate an increase in test volume</li> </ul>

<p><b>Level 5</b> <i>Creates an algorithm for test selection based on clinical history</i></p> <p><i>Creates a new protocol to assist the laboratory in the appraisal of specimen issues</i></p> <p><i>Independently develops a new laboratory workflow</i></p>	<ul style="list-style-type: none"> <li>● Creates an EHR pop-up box for providers to consider ordering plasma amino acids for a chief complaint of encephalopathy</li> <li>● Creates a Laboratory Information System (LIS) alert for specimens received beyond the acceptable time window</li> <li>● Creates a visual aide for the accessioning staff to help them determine if a specimen was collected in the correct tube</li> <li>● Creates a new workflow to immediately notify the supervisor when a STAT specimen is received</li> </ul>

**Patient Care 2: Analytic**

**Overall Intent:** To understand the analytic components of the assays performed in the lab and demonstrate competency in analysis

Milestones	Examples
<p><b>Level 1</b> <i>Describes basic principles for major assays performed in the laboratory</i></p> <p><i>Describes quality control (QC) in the clinical laboratory</i></p>	<ul style="list-style-type: none"> <li>• Discusses the underlying principles of amino acid analysis</li> <li>• Identifies the need for appropriate positive and negative controls for organic acid analysis</li> </ul>
<p><b>Level 2</b> <i>Performs assays, with substantial assistance</i></p> <p><i>Identifies QC failures</i></p>	<ul style="list-style-type: none"> <li>• Performs amino acid analysis following standard operating procedures</li> <li>• Recognizes when quality control results are outside of established limits</li> </ul>
<p><b>Level 3</b> <i>Performs assays, with minimal assistance</i></p> <p><i>Explains possible sources of QC failures</i></p>	<ul style="list-style-type: none"> <li>• Performs organic acid analysis following the standard operating procedures</li> <li>• Explains how contamination can be a source of QC failures</li> </ul>
<p><b>Level 4</b> <i>Independently performs assays</i></p> <p><i>Investigates QC failures and proposes resolution</i></p>	<ul style="list-style-type: none"> <li>• Demonstrates competency in acylcarnitine analysis</li> <li>• Identifies mobile phase contamination as a possible source of quality control failure and replaces the reagent</li> </ul>
<p><b>Level 5</b> <i>Develops new, alternate, or improved assay</i></p> <p><i>Identifies and implements a new QC approach for a clinical test</i></p>	<ul style="list-style-type: none"> <li>• Modifies an existing liquid chromatography–mass spectrometry (LC-MS/MS) assay to analyze underivatized compounds</li> <li>• Incorporates a new qualifier ion for peak identification in an established mass spectrometry-based assay</li> </ul>

<b>Patient Care 3: Post-Analytic Skills</b>	
<b>Overall Intent:</b> To provide clinically significant interpretation of lab results to effectively guide patient care	
<b>Milestones</b>	<b>Examples</b>
<p><b>Level 1</b> <i>Identifies normal results</i></p> <p><i>Discusses the importance of patient's clinical history to test interpretation</i></p>	<ul style="list-style-type: none"> <li>● Correctly identifies a normal amino acid result</li> <li>● Recognizes that dietary intake can impact amino acid levels</li> </ul>
<p><b>Level 2</b> <i>Interprets simple results, with assistance</i></p> <p><i>Gathers pertinent elements of the clinical history to aid in interpretation</i></p>	<ul style="list-style-type: none"> <li>● Correctly interprets that a large elevation of phenylalanine could indicate phenylketonuria (PKU)</li> <li>● Identifies medium-chain triglycerides (MCT) oil supplementation as a possible cause of medium-chain dicarboxylic aciduria</li> </ul>
<p><b>Level 3</b> <i>Interprets complex results, with assistance</i></p> <p><i>Integrates results with the clinical history to develop a final interpretation, with assistance</i></p>	<ul style="list-style-type: none"> <li>● Identifies an abnormal organic acid pattern consistent with propionic acidemia</li> <li>● Interprets the significance of hypermethioninemia in a patient with liver disease</li> </ul>
<p><b>Level 4</b> <i>Independently interprets results</i></p> <p><i>Independently integrates results with the clinical history to develop a final interpretation</i></p>	<ul style="list-style-type: none"> <li>● Correctly identifies an acylcarnitine pattern consistent with very-long-chain acyl-CoA dehydrogenase (VLCAD) deficiency</li> <li>● Integrates newborn screening, amino acid, organic acid, and blood chemistry results in a patient with likely cobalamin C disease, with recommendation for molecular confirmation</li> </ul>
<p><b>Level 5</b> <i>Develops an improved result interpretation workflow</i></p> <p><i>Identifies novel correlations between results and clinical history</i></p>	<ul style="list-style-type: none"> <li>● Develops an automated process for organic acid review and interpretation</li> <li>● Identifies a new biomarker associated with mitochondrial disease</li> </ul>
<p>Assessment Models or Tools</p>	<ul style="list-style-type: none"> <li>● Direct observation</li> <li>● Multisource feedback</li> <li>● Medical record (chart) audit</li> <li>● Report review</li> </ul>

**Patient Care 4: Reports**

**Overall Intent:** To generate effective clinical genetics reports for both simple and complex cases while using accurate terminology/nomenclature and providing appropriate recommendations

Milestones	Examples
<p><b>Level 1</b> <i>Identifies the elements of a laboratory report</i></p> <p><i>Identifies that reports can be revised</i></p>	<ul style="list-style-type: none"> <li>● In a report identifies sample type, date of collection, test name, clinical indication, test results, and interpretation as key elements of a report</li> <li>● Identifies that a typographical error can be corrected after a report is finalized</li> </ul>
<p><b>Level 2</b> <i>Drafts a report for simple cases using accurate terminology/ nomenclature, with assistance</i></p> <p><i>Identifies when to correct, amend, or addend a report based on the type of alteration required</i></p>	<ul style="list-style-type: none"> <li>● Drafts a report for normal plasma amino acids</li> <li>● Identifies that a wrong date of birth requires a corrected report</li> <li>● Identifies that a change in variant classification requires an amended report and possible re-contacting of providers</li> <li>● Identifies that additional test results require an addended report</li> </ul>
<p><b>Level 3</b> <i>Drafts a report for complex cases using accurate terminology/ nomenclature, with assistance</i></p> <p><i>Drafts a revised report, with assistance</i></p>	<ul style="list-style-type: none"> <li>● Drafts a report for findings of elevated valine, isoleucine, and leucine (with normal alloisoleucine) as being suggestive of maple syrup urine disease (MSUD) versus catabolic state</li> <li>● Drafts amended acylcarnitine profile report with findings of elevated C5OH to clarify its significance based on subsequent organic acid results</li> </ul>
<p><b>Level 4</b> <i>Independently generates concise reports for complex cases</i></p> <p><i>Independently generates a revised report</i></p>	<ul style="list-style-type: none"> <li>● Independently generates an acylcarnitine report for findings consistent with glutaric acidemia type II that clearly identifies glutaric acidemia type II as the ultimate diagnosis</li> <li>● Independently generates a report for findings of elevated valine, isoleucine, and leucine (with normal alloisoleucine) in a patient with ketosis as being consistent with catabolic state</li> <li>● Independently generates an addended report to include results of additional testing</li> <li>● Independently generates an addended acylcarnitine profile report with findings of elevated C5OH to clarify the maternal origin of the abnormality following testing of the mother</li> </ul>
<p><b>Level 5</b> <i>Develops a new reporting template for original or revised reports</i></p>	<ul style="list-style-type: none"> <li>● Develops a template to integrate findings of acylcarnitine profile and urine organic acids into a single interpretation</li> <li>● Creates an automated process for correcting reports</li> </ul>

<b>Medical Knowledge 1: Foundations of Medical Genetics and Genomics</b> <b>Overall Intent:</b> To progressively incorporate basic science knowledge into patient care

<b>Level 1</b> <i>Defines relevant medical terminology</i>  <i>Describes basic principles of medical biochemistry and cell biology</i>	<ul style="list-style-type: none"> <li>● Demonstrates understanding of common signs and symptoms of genetic conditions</li> <li>● Describes how the urea cycle detoxifies ammonia</li> <li>● Describes the role of the Krebs cycle in energy metabolism</li> </ul>
<b>Level 2</b> <i>Describes genetic conditions using accurate medical terminology</i>  <i>Describes normal metabolic processes</i>	<ul style="list-style-type: none"> <li>● Explains that hypoglycemia, metabolic acidosis, lethargy, and encephalopathy can be signs and symptoms of organic acidemias</li> <li>● Describes the process of fatty acid beta-oxidation</li> </ul>
<b>Level 3</b> <i>With assistance, assimilates and integrates medical information to generate a differential diagnosis</i>  <i>Describes abnormal metabolic processes and clinical phenotypes of associated diseases</i>	<ul style="list-style-type: none"> <li>● Recognizes that the clinical presentation can differentiate glycine encephalopathy from propionic acidemia for a patient with elevated plasma glycine</li> <li>● Describes the biochemical and clinical findings of pyridoxine dependent epilepsy</li> </ul>
<b>Level 4</b> <i>Independently assimilates and integrates medical information to generate a differential diagnosis</i>  <i>Describes the primary and secondary metabolic effects and clinical phenotypes of various inborn errors of metabolism</i>	<ul style="list-style-type: none"> <li>● Recognizes that the clinical presentation can help to differentiate glycine encephalopathy from propionic acidemia for a patient with elevated plasma glycine</li> <li>● Describes the etiology and clinical consequences of hyperammonemia in a neonate with methylmalonic acidemia</li> </ul>

**Overall Intent:** To understand how to critically evaluate test methodologies and the steps needed to design, assess, and validate a new laboratory test

<p><b>Level 1</b> <i>Defines the basic components of a test validation and verification</i></p> <p><i>Describes various methodologies used in a clinical biochemical genetics laboratory</i></p>	<ul style="list-style-type: none"> <li>● Defines sensitivity, specificity, positive/negative predictive values, and reproducibility</li> <li>● Describes the basic principles of chromatography</li> </ul>
<p><b>Level 2</b> <i>Describes methods and data used in establishing test performance characteristics for validation and verification</i></p> <p><i>Describes the strengths and limitations of a biochemical laboratory test</i></p>	<ul style="list-style-type: none"> <li>● Identifies the need for appropriate known normal and abnormal specimens for determining the test reference range or precision</li> <li>● Explains why acylcarnitine profiling is highly sensitive to elevations, but cannot distinguish between isomers</li> </ul>
<p><b>Level 3</b> <i>Determines test performance characteristics, with assistance</i></p> <p><i>Determines the optimal technologies and platforms for biochemical tests, with assistance</i></p>	<ul style="list-style-type: none"> <li>● Calculates sensitivity, specificity, positive/negative predictive value, and reproducibility</li> <li>● Identifies that a chromatography step is needed to differentiate between leucine, isoleucine, and alloisoleucine prior to detection and quantification by mass spectrometry</li> </ul>
<p><b>Level 4</b> <i>Independently calculates test performance characteristics</i></p> <p><i>Independently determines the optimal technologies and platforms for biochemical tests</i></p>	<ul style="list-style-type: none"> <li>● Calculates sensitivity, specificity, positive/negative predictive value and reproducibility</li> <li>● Selects a column for chromatography to differentiate between leucine, isoleucine, and alloisoleucine prior to detection and quantification by mass spectrometry</li> </ul>
