





2023-2024 Sponsoring Institutions by Status

Accreditation Statuses of Currently Accredited Sponsoring Institutions










10-Year and Data-Prompted Accreditation Decisions Compared







Recognition for Non-Standard Training Programs

- Recognition of a Sponsoring Institution to provide:
 - *Clinical* training in advanced subspecialty programs
 - No ACGME program
 - No American Board of Medical Specialties (ABMS) Member Board certification
 - J-1 visa holder foreign national physicians
 - Individual programs are not recognized but must meet qualifications
- NST site visit process
 - NST Annual Update process will follow
 - ADS process enhancements
