## Definitions

**Core Requirements:** Statements that define structure, resource, or process elements essential to every graduate medical educational program.

**Detail Requirements:** Statements that describe a specific structure, resource, or process, for achieving compliance with a Core Requirement. Programs and sponsoring institutions in substantial compliance with the Outcome Requirements may utilize alternative or innovative approaches to meet Core Requirements.

**Outcome Requirements:** Statements that specify expected measurable or observable attributes (knowledge, abilities, skills, or attitudes) of residents or fellows at key stages of their graduate medical education.

## ACGME Program Requirements for Graduate Medical Education in Adult Congenital Heart Disease

### Common Program Requirements (One-Year Fellowship) are in BOLD

Where applicable, text in italics describes the underlying philosophy of the requirements in that section. These philosophic statements are not program requirements and are therefore not citable.

**Background and Intent:** These fellowship requirements reflect the fact that these learners have already completed the first phase of graduate medical education. Thus, the Common Program Requirements (One-Year Fellowship) are intended to explain the differences.

## Introduction

### Definition of Graduate Medical Education

*Fellowship is advanced graduate medical education beyond a core residency program for physicians who desire to enter more specialized practice. Fellowship-trained physicians serve the public by providing subspecialty care, which may also include core medical care, acting as a community resource for expertise in their field, creating and integrating new knowledge into practice, and educating future generations of physicians. Graduate medical education values the strength that a diverse group of physicians brings to medical care, and the importance of inclusive and psychologically safe learning environments.*

*Fellows who have completed residency are able to practice autonomously in their core specialty. The prior medical experience and expertise of fellows distinguish them from physicians entering residency. The fellow's care of patients within the subspecialty is undertaken with appropriate faculty supervision and conditional independence. Faculty members serve as role models of excellence, compassion, cultural sensitivity, professionalism, and scholarship. The fellow develops deep medical knowledge, patient care skills, and expertise applicable to their focused area of practice. Fellowship is an intensive program of subspecialty clinical and didactic education that focuses on the multidisciplinary care of patients. Fellowship education is often physically, emotionally, and intellectually demanding, and occurs in a variety of clinical learning environments committed to graduate medical education and the well-being of patients, residents, fellows, faculty members, students, and all members of the health care team.*

*In addition to clinical education, many fellowship programs advance fellows' skills as physician-scientists. While the ability to create new knowledge within medicine is not exclusive to fellowship-educated physicians, the fellowship experience expands a physician's abilities to pursue hypothesis-driven scientific inquiry that results in contributions to the medical literature and patient care. Beyond the clinical subspecialty expertise achieved, fellows develop mentored relationships built on an infrastructure that promotes collaborative research.*

## Definition of Subspecialty

*Adult congenital heart disease (ACHD) encompasses the unique knowledge and skills required to care for adult patients who experienced developmental defects in one or more structures of the heart or blood vessels. This care regularly requires coordination of multiple health-related influences or providers, potentially over a prolonged or indefinite timeframe.*

## Section 1: Oversight

### Sponsoring Institution

***The Sponsoring Institution is the organization or entity that assumes the ultimate financial and academic responsibility for a program of graduate medical education consistent with the ACGME Institutional Requirements.***

***When the Sponsoring Institution is not a rotation site for the program, the most commonly utilized site of clinical activity for the program is the primary clinical site.***

**Background and Intent:** Participating sites will reflect the health care needs of the community and the educational needs of the fellows. A wide variety of organizations may provide a robust educational experience and, thus, Sponsoring Institutions and participating sites may encompass inpatient and outpatient settings including, but not limited to a university, a medical school, a teaching hospital, a nursing home, a school of public health, a health department, a public health agency, an organized health care delivery system, a medical examiner's office, an educational consortium, a teaching health center, a physician group practice, a federally qualified health center, a surgery center, an academic and private single-specialty clinic, or an educational foundation.

- 1.1. The program must be sponsored by one ACGME-accredited Sponsoring Institution. <sup>(Core)</sup>

### Participating Sites

***A participating site is an organization providing educational experiences or educational assignments/rotations for fellows.***

- 1.2. The program, with approval of its Sponsoring Institution, must designate a primary clinical site. <sup>(Core)</sup>
  - 1.2.a. An ACHD fellowship must function as an integral part of an ACGME-accredited fellowship in cardiovascular disease. <sup>(Core)</sup>
  - 1.2.b. There must be a collaborative relationship with the program director of the cardiovascular disease program to ensure compliance with the ACGME accreditation requirements. <sup>(Core)</sup>

**Subspecialty-Specific Background and Intent:** Ways to achieve this collaboration include participating in Clinical Competency Committee meetings or program evaluation meetings

as well as having joint faculty development meetings. Such opportunities facilitate the dissemination of best practices for education and well-being, provide the opportunity to share expertise across programs, and promote faculty interaction and program development.

- 1.3. There must be a program letter of agreement (PLA) between the program and each participating site that governs the relationship between the program and the participating site providing a required assignment. (Core)**
  - 1.3.a. The PLA must be renewed at least every 10 years. (Core)**
  - 1.3.b. The PLA must be approved by the designated institutional official (DIO). (Core)**
- 1.4. The program must monitor the clinical learning and working environment at all participating sites. (Core)**
- 1.5. At each participating site there must be one faculty member, designated by the program director, who is accountable for fellow education for that site, in collaboration with the program director. (Core)**

**Background and Intent:** While all fellowship programs must be sponsored by a single ACGME-accredited Sponsoring Institution, many programs will utilize other clinical settings to provide required or elective training experiences. At times it is appropriate to utilize community sites that are not owned by or affiliated with the Sponsoring Institution. Some of these sites may be remote for geographic, transportation, or communication issues. When utilizing such sites, the program must designate a faculty member responsible for ensuring the quality of the educational experience. In some circumstances, the person charged with this responsibility may not be physically present at the site, but remains responsible for fellow education occurring at the site.

**Suggested elements to be considered in PLAs will be found in the Guide to the Common Program Requirements. These include:**

- Identifying the faculty members who will assume educational and supervisory responsibility for fellows**
- Specifying the responsibilities for teaching, supervision, and formal evaluation of fellows**
- Specifying the duration and content of the educational experience**
- Stating the policies and procedures that will govern fellow education during the assignment**

- 1.6. The program director must submit any additions or deletions of participating sites routinely providing an educational experience, required for all fellows, of one month full time equivalent (FTE) or more through the ACGME's Accreditation Data System (ADS). (Core)**

- 1.6.a. The program should ensure that fellows are not unduly burdened by required rotations at geographically distant sites. <sup>(Core)</sup>

Subspecialty-Specific Background and Intent: The Review Committee considers a participating site to be geographically distant if the distance between the site and the primary clinical site exceeds 60 miles. The Review Committee acknowledges that programs may need to use geographically distant sites to provide fellows with specific required educational experiences not available at the primary clinical site or other participating sites. It also notes that such rotations can be disruptive to fellow well-being, adversely impact faculty member/fellow team interactions and cohesion, diminish participation in educational experiences (e.g., conference attendance/participation, scholarly activity, and continuity of care), and be burdensome for fellows. Programs will need to consider these issues when using geographically distant sites and implement actions to mitigate them. Providing travel and/or housing reimbursement for fellows rotating at a required geographically distant site is one way the program can offset the potential adverse impact on fellow well-being. Programs will need to be transparent and inform fellows that geographically distant sites are used.

**1.7. Workforce Recruitment and Retention**

**The program, in partnership with its Sponsoring Institution, must engage in practices that focus on mission-driven, ongoing, systematic recruitment and retention of a diverse and inclusive workforce of residents (if present), fellows, faculty members, senior administrative GME staff members, and other relevant members of its academic community.** <sup>(Core)</sup>

**Background and Intent: It is expected that the Sponsoring Institution has, and programs implement, policies and procedures related to recruitment and retention of individuals underrepresented in medicine and medical leadership in accordance with the Sponsoring Institution’s mission and aims.**

**1.8. Resources**

**The program, in partnership with its Sponsoring Institution, must ensure the availability of adequate resources for fellow education.** <sup>(Core)</sup>

- 1.8.a. The program, in partnership with its Sponsoring Institution, must ensure the program has adequate space available, including meeting rooms, classrooms, examination rooms, computers, visual and other educational aids, and office space. <sup>(Core)</sup>
- 1.8.b. The program, in partnership with its Sponsoring Institution, ensure that appropriate in-person or remote/virtual consultations, including those done using telecommunication technology, are available in settings in which fellows work. <sup>(Core)</sup>
- 1.8.c. The program, in partnership with its Sponsoring Institution, provide access to an electronic health record (EHR). <sup>(Core)</sup>

Subspecialty-Specific Background and Intent: An EHR can include electronic notes, orders, and lab reporting. Such a system also facilitates data reporting regarding the care provided to a patient or a panel of patients. It may also include systems for enhancing the quality and safety of patient care. An EHR does not have to be present at all participating sites and does not have to include every element of patient care information. However, a system that simply reports laboratory or imaging results does not meet the definition of an EHR.

- 1.8.d. The program, in partnership with its Sponsoring Institution, provide fellows with access to training using simulation to support fellow education and patient safety. (Core)

Subspecialty-Specific Background and Intent: The Review Committee does not expect each program to own a simulator or to have a simulation center. "Simulation" is used broadly to mean learning about patient care in settings that do not include actual patients. This could include objective structured clinical examinations (OSCEs), standardized patients, patient simulators, or electronic simulation of resuscitation, procedures, and other clinical scenarios.

- 1.8.e. The program must provide fellows with a patient population representative of both the broad spectrum of clinical disorders and medical conditions managed by subspecialists in this area, and of the community being served by the program. (Core)

- 1.8.e.1. This must include at least 100 hospitalized adult patients diagnosed with complications related to congenital heart disease. (Core)

- 1.8.e.2. This must include at least 275 ambulatory patient visits (among at least 150 unique individual ambulatory patients) with congenital heart disease. (Core)

- 1.9. **The program, in partnership with its Sponsoring Institution, must ensure healthy and safe learning and working environments that promote fellow well-being and provide for:**

- 1.9.a. **access to food while on duty;** (Core)

- 1.9.b. **safe, quiet, clean, and private sleep/rest facilities available and accessible for fellows with proximity appropriate for safe patient care, if the fellows are assigned in-house call;** (Core)

**Background and Intent: Care of patients within a hospital or health system occurs continually through the day and night. Such care requires that fellows function at their peak abilities, which requires the work environment to provide them with the ability to meet their basic needs within proximity of their clinical responsibilities. Access to food and rest are examples of these basic needs, which must be met while fellows are working. Fellows should have access to refrigeration where food may be stored. Food should be available when fellows are required to be in the hospital overnight. Rest**



facilities are necessary, even when overnight call is not required, to accommodate the fatigued fellow.

- 1.9.c. clean and private facilities for lactation that have refrigeration capabilities, with proximity appropriate for safe patient care; (Core)

**Background and Intent:** Sites must provide private and clean locations where fellows may lactate and store the milk within a refrigerator. These locations should be in close proximity to clinical responsibilities. It would be helpful to have additional support within these locations that may assist the fellow with the continued care of patients, such as a computer and a phone. While space is important, the time required for lactation is also critical for the well-being of the fellow and the fellow's family, as outlined in 6.13.c.1.

- 1.9.d. security and safety measures appropriate to the participating site; and, (Core)

- 1.9.e. accommodations for fellows with disabilities consistent with the Sponsoring Institution's policy. (Core)

- 1.10. Fellows must have ready access to subspecialty-specific and other appropriate reference material in print or electronic format. This must include access to electronic medical literature databases with full text capabilities. (Core)

- 1.11. **Other Learners and Health Care Personnel**  
The presence of other learners and health care personnel, including but not limited to residents from other programs, subspecialty fellows, and advanced practice providers, must not negatively impact the appointed fellows' education. (Core)

**Background and Intent:** The clinical learning environment has become increasingly complex and often includes care providers, students, and post-graduate residents and fellows from multiple disciplines. The presence of these practitioners and their learners enriches the learning environment. Programs have a responsibility to monitor the learning environment to ensure that fellows' education is not compromised by the presence of other providers and learners, and that fellows' education does not compromise core residents' education.

## Section 2: Personnel

- 2.1. **Program Director**  
There must be one faculty member appointed as program director with authority and accountability for the overall program, including compliance with all applicable program requirements. (Core)

**2.2. The Sponsoring Institution’s Graduate Medical Education Committee (GMEC) must approve a change in program director and must verify the program director’s licensure and clinical appointment. (Core)**

**2.2.a. Final approval of the program director resides with the Review Committee. (Core)**

**Background and Intent: While the ACGME recognizes the value of input from numerous individuals in the management of a fellowship, a single individual must be designated as program director and have overall responsibility for the program. The program director’s nomination is reviewed and approved by the GMEC.**

**2.3. The program director and, as applicable, the program’s leadership team, must be provided with support adequate for administration of the program based upon its size and configuration. (Core)**

2.3.a. At a minimum, the program director must be provided with the dedicated time and support specified below for administration of the program: (Core)

2.3.b. Programs must appoint at least one of the subspecialty-certified core faculty members to be associate program director(s). (Core)

2.3.c. The associate program director(s) must be provided with support equal to a dedicated minimum time for administration of the program as follows: (Core)

**Background and Intent:** To achieve successful graduate medical education, individuals serving as education and administrative leaders of fellowship programs, as well as those significantly engaged in the education, supervision, evaluation, and mentoring of fellows, must have sufficient dedicated professional time to perform the vital activities required to sustain an accredited program.

The ultimate outcome of graduate medical education is excellence in fellow education and patient care.

The program director and, as applicable, the program leadership team, devote a portion of their professional effort to the oversight and management of the fellowship program, as defined in 2.5. – 2.5.I. Both provision of support for the time required for the leadership effort and flexibility regarding how this support is provided are important. Programs, in partnership with their Sponsoring Institutions, may provide support for this time in a variety of ways. Examples of support may include, but are not limited to, salary support, supplemental compensation, educational value units, or relief of time from other professional duties.

Program directors and, as applicable, members of the program leadership team, who are new to the role may need to devote additional time to program oversight and management initially as they learn and become proficient in administering the program. It is suggested that during this initial period the support described above be increased as needed.

In addition, it is important to remember that the dedicated time and support requirement for ACGME activities is a *minimum*, recognizing that, depending on the unique needs of the program, additional support may be warranted. The need to ensure adequate resources, including adequate support and dedicated time for the program director, is also addressed in Institutional Requirement 2.2.a. The amount of support and dedicated time needed for individual programs will vary based on a number of factors and may exceed the minimum specified in the applicable specialty/subspecialty-specific Program Requirements. It is expected that the Sponsoring Institution, in partnership with its accredited programs, will ensure support for program directors to fulfill their program responsibilities effectively.

Subspecialty-Specific Background and Intent: For programs with fewer than seven fellows, there is no separate minimum associate program director FTE support beyond what is specified for core faculty members. Programs will need to use the minimum aggregate FTE for core faculty members to support the associate program director, who is also a core faculty member. See the Subspecialty-Specific Background and Intent box in the core faculty section (2.10.c.) for clarification of expectations for associate program director FTE support for programs with approved complements of fewer than seven fellows.

#### **2.4. Qualifications of the Program Director**

**The program director must possess subspecialty expertise and qualifications acceptable to the Review Committee. (Core)**

**2.4.a. The program director must possess current certification in the subspecialty for which they are the program director by the American Board of Internal Medicine (ABIM) or subspecialty qualifications that are acceptable to the Review Committee. (Core)**

[Note that while the Common Program Requirements deem certification by a certifying board of the American Osteopathic Association (AOA) acceptable, there is no AOA board that offers certification in this subspecialty.]

2.4.a.1. The Review Committee only accepts current ABIM certification in ACHD. (Core)

2.4.b. The program director must have at least three years of documented educational and/or administrative experience in an ACGME-accredited fellowship in internal medicine cardiovascular disease, pediatric cardiology, or ACHD. (Core)

Subspecialty-Specific Background and Intent: The educational/administrative experience can be as program director, associate program director, core faculty member, or faculty member for an ACGME accredited cardiovascular disease, pediatric cardiology, or ACHD. The experience does not include time spent as a fellow. Teaching/administrative experience is cumulative across multiple programs.

## **2.5. Program Director Responsibilities**

**The program director must have responsibility, authority, and accountability for: administration and operations; teaching and scholarly activity; fellow recruitment and selection, evaluation, and promotion of fellows, and disciplinary action; supervision of fellows; and fellow education in the context of patient care. (Core)**

2.5.a. The program director must be a role model of professionalism. (Core)

**Background and Intent: The program director, as the leader of the program, must serve as a role model to fellows in addition to fulfilling the technical aspects of the role. As fellows are expected to demonstrate compassion, integrity, and respect for others, they must be able to look to the program director as an exemplar. It is of utmost importance, therefore, that the program director model outstanding professionalism, high quality patient care, educational excellence, and a scholarly approach to work. The program director creates an environment where respectful discussion is welcome, with the goal of continued improvement of the educational experience.**

2.5.b. The program director must design and conduct the program in a fashion consistent with the needs of the community, the mission(s) of the Sponsoring Institution, and the mission(s) of the program. (Core)

**Background and Intent: The mission of institutions participating in graduate medical education is to improve the health of the public. Each community has health needs that vary based upon location and demographics. Programs must understand the structural and social determinants of health of the populations they serve and incorporate them**

in the design and implementation of the program curriculum, with the ultimate goal of addressing these needs and eliminating health disparities.

- 2.5.c. The program director must administer and maintain a learning environment conducive to educating the fellows in each of the ACGME Competency domains. (Core)

**Background and Intent:** The program director may establish a leadership team to assist in the accomplishment of program goals. Fellowship programs can be highly complex. In a complex organization the leader typically has the ability to delegate authority to others, yet remains accountable. The leadership team may include physician and non-physician personnel with varying levels of education, training, and experience.

- 2.5.d. The program director must have the authority to approve or remove physicians and non-physicians as faculty members at all participating sites, including the designation of core faculty members, and must develop and oversee a process to evaluate candidates prior to approval. (Core)

**Background and Intent:** The provision of optimal and safe patient care requires a team approach. The education of fellows by non-physician educators may enable the fellows to better manage patient care and provides valuable advancement of the fellows' knowledge. Furthermore, other individuals contribute to the education of fellows in the basic science of the subspecialty or in research methodology. If the program director determines that the contribution of a non-physician individual is significant to the education of the fellow, the program director may designate the individual as a program faculty member or a program core faculty member.

- 2.5.e. The program director must have the authority to remove fellows from supervising interactions and/or learning environments that do not meet the standards of the program. (Core)

**Background and Intent:** The program director has the responsibility to ensure that all who educate fellows effectively role model the Core Competencies. Working with a fellow is a privilege that is earned through effective teaching and professional role modeling. This privilege may be removed by the program director when the standards of the clinical learning environment are not met.

There may be faculty in a department who are not part of the educational program, and the program director controls who is teaching the residents.

- 2.5.f. The program director must submit accurate and complete information required and requested by the DIO, GMEC, and ACGME. (Core)

**Background and Intent:** This includes providing information in the form and format requested by the ACGME and obtaining requisite sign-off by the DIO.

- 2.5.g. The program director must provide a learning and working environment in which fellows have the opportunity to raise concerns, report mistreatment, and provide feedback in a confidential manner as appropriate, without fear of intimidation or retaliation. (Core)
- 2.5.h. The program director must ensure the program's compliance with the Sponsoring Institution's policies and procedures related to grievances and due process, including when action is taken to suspend or dismiss, not to promote or renew the appointment of a fellow. (Core)

**Background and Intent:** A program does not operate independently of its Sponsoring Institution. It is expected that the program director will be aware of the Sponsoring Institution's policies and procedures, and will ensure they are followed by the program's leadership, faculty members, support personnel, and fellows.

- 2.5.i. The program director must ensure the program's compliance with the Sponsoring Institution's policies and procedures on employment and non-discrimination. (Core)
- 2.5.j. The program director must document verification of education for all fellows within 30 days of completion of or departure from the program. (Core)
- 2.5.k. The program director must provide verification of an individual fellow's education upon the fellow's request, within 30 days. (Core)

**Background and Intent:** Primary verification of graduate medical education is important to credentialing of physicians for further training and practice. Such verification must be accurate and timely. Sponsoring Institution and program policies for record retention are important to facilitate timely documentation of fellows who have previously completed the program. Fellows who leave the program prior to completion also require timely documentation of their summative evaluation.

## Faculty

*Faculty members are a foundational element of graduate medical education – faculty members teach fellows how to care for patients. Faculty members provide an important bridge allowing fellows to grow and become practice ready, ensuring that patients receive the highest quality of care. They are role models for future generations of physicians by demonstrating compassion, commitment to excellence in teaching and patient care, professionalism, and a dedication to lifelong learning. Faculty members experience the pride and joy of fostering the growth and development of future colleagues. The care they provide is enhanced by the opportunity to teach and model exemplary behavior. By employing a scholarly approach to patient care, faculty members, through the graduate medical education system, improve the health of the individual and the population.*

*Faculty members ensure that patients receive the level of care expected from a specialist in the field. They recognize and respond to the needs of the patients, fellows, community, and institution. Faculty members provide appropriate levels of supervision to promote*

***patient safety. Faculty members create an effective learning environment by acting in a professional manner and attending to the well-being of the fellows and themselves.***

**Background and Intent: “Faculty” refers to the entire teaching force responsible for educating fellows. The term “faculty,” including “core faculty,” does not imply or require an academic appointment.**

**2.6. There must be a sufficient number of faculty members with competence to instruct and supervise all fellows. (Core)**

2.6.a. The physician faculty should include members with documented experience and expertise in:

2.6.a.1. both inpatient and outpatient management of cardiovascular care of adults with congenital heart disease; (Detail)

2.6.a.2. catheterization of patients with congenital heart lesions, and catheter-based interventions in adult and pediatric patients; (Detail)

2.6.a.3. congenital cardiac and vascular basic and advanced imaging; (Detail)

2.6.a.4. congenital heart disease surgery in both pediatric and adult patients; (Detail)

2.6.a.5. pediatric and adult congenital heart electrophysiology; (Detail)

2.6.a.6. catheterization of patients with congenital heart lesions, and catheter-based interventions in adult and pediatric patients; (Detail)

2.6.a.7. congenital cardiac and vascular basic and advanced imaging; (Detail)

2.6.a.8. critical care and post-operative management of adults with congenital heart disease; (Detail)

2.6.a.9. heart failure, mechanical circulatory and ventilator support, and both heart and lung transplantation; (Detail)

2.6.a.10. medical research methodology; and, (Detail)

2.6.a.11. pulmonary vascular disease. (Detail)

**2.7. Faculty Responsibilities**

**Faculty members must be role models of professionalism. (Core)**

**2.7.a. Faculty members must demonstrate commitment to the delivery of safe, equitable, high-quality, cost-effective, patient-centered care. (Core)**

**Background and Intent: Patients have the right to expect quality, cost-effective care with patient safety at its core. The foundation for meeting this expectation is formed**

during residency and fellowship. Faculty members model these goals and continually strive for improvement in care and cost, embracing a commitment to the patient and the community they serve.

- 2.7.b. Faculty members must demonstrate a strong interest in the education of fellows, including devoting sufficient time to the educational program to fulfill their supervisory and teaching responsibilities. (Core)
- 2.7.c. Faculty members must administer and maintain an educational environment conducive to educating fellows. (Core)
- 2.7.d. Faculty members must regularly participate in organized clinical discussions, rounds, journal clubs, and conferences. (Core)
- 2.7.e. Faculty members must pursue faculty development designed to enhance their skills. (Core)
- 2.7.f. Faculty members must encourage and support fellows in scholarly activities. (Core)
- 2.8. **Faculty Qualifications**  
Faculty members must have appropriate qualifications in their field and hold appropriate institutional appointments. (Core)
- 2.9. **Subspecialty Physician Faculty Members**  
Subspecialty physician faculty members must have current certification in the subspecialty by the American Board of Internal Medicine or possess qualifications judged acceptable to the Review Committee. (Core)
- [Note that while the Common Program Requirements deem certification by a certifying board of the American Osteopathic Association (AOA) acceptable, there is no AOA board that offers certification in this subspecialty.]
- 2.9.a. Any other specialty physician faculty members must have current certification in their specialty by the appropriate American Board of Medical Specialties (ABMS) member board or American Osteopathic Association (AOA) certifying board, or possess qualifications judged acceptable to the Review Committee. (Core)
- 2.10. **Core Faculty**  
Core faculty members must have a significant role in the education and supervision of fellows and must devote a significant portion of their entire effort to fellow education and/or administration, and must, as a component of their activities, teach, evaluate, and provide formative feedback to fellows. (Core)

**Background and Intent: Core faculty members are critical to the success of fellow education. They support the program leadership in developing, implementing, and assessing curriculum, mentoring fellows, and assessing fellows' progress toward**



achievement of competence in and the autonomous practice of the specialty. Core faculty members should be selected for their broad knowledge of and involvement in the program, permitting them to effectively evaluate the program. Core faculty members may also be selected for their specific expertise and unique contributions to the program. Core faculty members are engaged in a broad range of activities, which may vary across programs and specialties. Core faculty members provide clinical teaching and supervision of fellows, and also participate in non-clinical activities related to fellow education and program administration. Examples of these non-clinical activities include, but are not limited to, interviewing and selecting fellow applicants, providing didactic instruction, mentoring fellows, simulation exercises, completing the annual ACGME Faculty Survey, and participating on the program's Clinical Competency Committee, Program Evaluation Committee, and other GME committees.

**2.10.a. Faculty members must complete the annual ACGME Faculty Survey.** (Core)

2.10.b. In addition to the program director, programs must have the minimum number of core faculty members who are certified in adult congenital heart disease by the ABIM based on the number of approved fellow positions, as follows: (Core)

2.10.c. The required core faculty members must be provided with support equal to an aggregate minimum of 10 percent/FTE for educational and administrative responsibilities that do not involve direct patient care. Support must be provided based on the program size as follows: (Core)

Subspecialty-Specific Background and Intent: The Review Committee created the table below to summarize the total minimum FTE for program director, associate program director(s), and core faculty members needed based on approved complement. The table also clarifies the minimum number of core faculty members necessary based on program size. Two examples are provided.

- A two-fellow program needs a program director and a minimum of one ABIM or AOBIM subspecialty-certified core faculty member (who is also the associate program director) and a total minimum FTE of 30 percent. This total minimum FTE is a sum of the minimum of 20 percent for the program director and an aggregate of 10 percent for the associate program director/other core faculty member.
- An eight-fellow program needs a program director and a minimum of four ABIM or AOBIM subspecialty-certified core faculty members (at least one being the associate program director) and a total minimum FTE of 58 percent. The total minimum FTE is a sum of the minimum of 25 percent/FTE for the program director, an aggregate of 13 percent/FTE for the associate program director(s), and an aggregate of 20 percent/FTE for the remaining core faculty members.

As long as the program meets the requirements for the minimum FTE for the program director, the minimum number of ABIM- or AOBIM-certified core faculty members, and the aggregate FTE for core faculty members and associate program director(s), programs may exercise flexibility in how the aggregate FTE for core faculty members and associate program director(s) is distributed. For instance, in the two-fellow program example, the program can allocate the aggregate 10 percent/FTE in whatever manner the program and institutional leadership feel works best.

**Background and Intent: Provision of support for the time required for the core faculty members' responsibilities related to fellow education and/or administration of the program, as well as flexibility regarding how this support is provided, are important. Programs, in partnership with their Sponsoring Institutions, may provide support for this time in a variety of ways. Examples of support may include, but are not limited to, salary support, supplemental compensation, educational value units, or relief of time from other professional duties.**

**It is important to remember that the dedicated time and support requirement is a *minimum*, recognizing that, depending on the unique needs of the program, additional support may be warranted. The need to ensure adequate resources, including adequate support and dedicated time for the core faculty members, is also addressed in Institutional Requirement 2.2.b. The amount of support and dedicated time needed for individual programs will vary based on a number of factors and may exceed the minimum specified in the applicable specialty-/subspecialty-specific Program Requirements.**

## 2.11. Program Coordinator

**There must be administrative support for program coordination. (Core)**

- 2.11.a. At a minimum, the program coordinator must be provided with the dedicated time and support specified below for administration of the program. Additional administrative support must be provided based on the program size as follows: (Core)

Subspecialty-Specific Background and Intent: As an example, a program with an approved complement of 12 fellows is required to have at least 74 percent/FTE administrative support: 30 percent/FTE for the program coordinator; and an additional 44 percent/FTE aggregate support. This additional support may be for the program coordinator only or divided among the program coordinator and one or more other administrative personnel. The Review Committee has not specified how the FTE should be distributed to allow programs, in partnership with their Sponsoring Institution, to allocate the FTE as they see fit.

**Background and Intent: The requirement does not address the source of funding required to provide the specified salary support.**

**2.12. Other Program Personnel**

**The program, in partnership with its Sponsoring Institution , must jointly ensure the availability of necessary personnel for the effective administration of the program. (Core)**

**Background and Intent: Multiple personnel may be required to effectively administer a program. These may include staff members with clerical skills, project managers, education experts, and staff members to maintain electronic communication for the program. These personnel may support more than one program in more than one discipline.**

## Section 3: Fellow Appointments

**3.1. Fellows must not be required to sign a non-competition guarantee or restrictive covenant. (Core)**

**3.2. Eligibility Requirements – Fellowship Programs**

**All required clinical education for entry into ACGME-accredited fellowship programs must be completed in an ACGME-accredited residency program, an AOA-approved residency program, a program with ACGME International (ACGME-I) Advanced Specialty Accreditation, or a Royal College of Physicians and**

**Surgeons of Canada (RCPSC)-accredited or College of Family Physicians of Canada (CFPC)-accredited residency program located in Canada. (Core)**

- 3.2.a. Fellowship programs must receive verification of each entering fellow's level of competence in the required field using ACGME, ACGME-I, or CanMEDS Milestones evaluations from the core residency program. (Core)**

**Background and Intent: A reporting feature is available for fellowship programs within ADS to provide fellowship program directors access to the final Milestones report for an active fellow's most recently completed residency program. These reports are available to fellowship program directors in mid-July, and use of this system to retrieve the reports is encouraged. There are a few scenarios in which these reports may not be available, such as if a fellow completed residency in a program not accredited by the ACGME, if a fellow completed residency prior to the Milestones implementation, or if a fellow's previous experience could not be matched when entered into the program. For those without Milestones reports, programs must contact the specialty program director from the fellow's most recent residency program to obtain the required information. This new reporting feature can be found in ADS by logging in and navigating to the program's "Reports" tab, and then selecting the "Residency Milestone Retrieval" option.**

- 3.2.a.1. Prior to appointment in the program, fellows should have completed a three-year cardiovascular disease or pediatric cardiology program that satisfies the requirements in 3.2. (Core)**
- 3.2.a.1.a. Fellows who did not complete a cardiovascular disease or pediatric cardiology program that satisfies the requirements in 3.2. must have completed at least three years of cardiovascular disease or pediatric cardiology education prior to starting the fellowship as well as met all of the criteria in the "Fellow Eligibility Exception" section below. (Core)**
- 3.2.b. Fellow Eligibility Exception**  
**The Review Committee for Internal Medicine will allow the following exception to the fellowship eligibility requirements:**
- 3.2.b.1. An ACGME-accredited fellowship program may accept an exceptionally qualified international graduate applicant who does not satisfy the eligibility requirements listed in 3.2., but who does meet all of the following additional qualifications and conditions: (Core)**
- 3.2.b.1.a. evaluation by the program director and fellowship selection committee of the applicant's suitability to enter the program, based on prior training and review of the summative evaluations of training in the core specialty; and, (Core)**
- 3.2.b.1.b. review and approval of the applicant's exceptional qualifications by the GMEC; and, (Core)**

3.2.b.1.c. verification of Educational Commission for Foreign Medical Graduates (ECFMG) certification. (Core)

3.2.b.2. Applicants accepted through this exception must have an evaluation of their performance by the Clinical Competency Committee within 12 weeks of matriculation. (Core)

**Background and Intent:** An exceptionally qualified international graduate applicant has (1) completed a residency program in the core specialty outside the continental United States that was not accredited by the ACGME, AOA, ACGME-I, RCPSC or CFPC, and (2) demonstrated clinical excellence, in comparison to peers, throughout training. Additional evidence of exceptional qualifications is required, which may include one of the following: (a) participation in additional clinical or research training in the specialty or subspecialty; (b) demonstrated scholarship in the specialty or subspecialty; and/or (c) demonstrated leadership during or after residency. Applicants being considered for these positions must be informed of the fact that their training may not lead to certification by ABMS member boards or AOA certifying boards.

In recognition of the diversity of medical training around the world, this early evaluation of clinical competence required for these applicants ensures they can provide quality and safe patient care. Any gaps in competence should be addressed as per policies for fellows already established by the program in partnership with the Sponsoring Institution.

### 3.3. Fellow Complement

The program director must not appoint more fellows than approved by the Review Committee. (Core)

**Background and Intent:** Programs are required to request approval of all complement changes, whether temporary or permanent, by the Review Committee through ADS. Permanent increases require prior approval from the Review Committee and temporary increases may also require approval. Specialty-specific instructions for requesting a complement increase are found in the “Documents and Resources” page of the applicable specialty section of the ACGME website.

## Section 4: Educational Program

*The ACGME accreditation system is designed to encourage excellence and innovation in graduate medical education regardless of the organizational affiliation, size, or location of the program.*

*The educational program must support the development of knowledgeable, skillful physicians who provide compassionate care.*

*It is recognized that programs may place different emphasis on research, leadership, public health, etc. It is expected that the program aims will reflect the nuanced program-specific goals for it and its graduates; for example, it is expected that a program aiming to prepare physician-scientists will have a different curriculum from one focusing on community health.*

**4.1. Length of Educational Program**

The educational program in ACHD must be 24 months in length. (Core)

**4.2. Educational Components**

The curriculum must contain the following educational components:

**4.2.a. a set of program aims consistent with the Sponsoring Institution’s mission, the needs of the community it serves, and the desired distinctive capabilities of its graduates, which must be made available to program applicants, fellows, and faculty members; (Core)**

**4.2.b. competency-based goals and objectives for each educational experience designed to promote progress on a trajectory to autonomous practice in their subspecialty. These must be distributed, reviewed, and available to fellows and faculty members; (Core)**

**4.2.c. delineation of fellow responsibilities for patient care, progressive responsibility for patient management, and graded supervision in their subspecialty; (Core)**

**Background and Intent:** These responsibilities may generally be described by PGY level and specifically by Milestones progress as determined by the Clinical Competency Committee. This approach encourages the transition to competency-based education. An advanced learner may be granted more responsibility independent of PGY level and a learner needing more time to accomplish a certain task may do so in a focused rather than global manner.

**4.2.d. structured educational activities beyond direct patient care; and, (Core)**

**Background and Intent:** Patient care-related educational activities, such as morbidity and mortality conferences, tumor boards, surgical planning conferences, case discussions, etc., allow fellows to gain medical knowledge directly applicable to the patients they serve. Programs should define those educational activities in which fellows are expected to participate and for which time is protected. Further specification can be found in 4.10. – 4.12.

**4.2.e. formal educational activities that promote patient safety-related goals, tools, and techniques. (Core)**

**ACGME Competencies**

*The Competencies provide a conceptual framework describing the required domains for a trusted physician to enter autonomous practice. These Competencies are core to the*

*practice of all physicians, although the specifics are further defined by each subspecialty. The developmental trajectories in each of the Competencies are articulated through the Milestones for each subspecialty. The focus in fellowship is on subspecialty-specific patient care and medical knowledge, as well as refining the other competencies acquired in residency.*

The program must integrate all ACGME Competencies into the curriculum.

**4.3. ACGME Competencies – Professionalism**

Fellows must demonstrate a commitment to professionalism and an adherence to ethical principles. (Core)

**4.4. ACGME Competencies – Patient Care**

Fellows must be able to provide patient care that is patient- and family-centered, compassionate, equitable, appropriate, and effective for the treatment of health problems and the promotion of health. (Core)

**Background and Intent: Quality patient care is safe, effective, timely, efficient, patient-centered, equitable, and designed to improve population health, while reducing per capita costs. In addition, there should be a focus on improving the clinician’s well-being as a means to improve patient care and reduce burnout among residents, fellows, and practicing physicians.**

4.4.a. Fellows must demonstrate competence in prevention education, evaluation, and management of inpatients and outpatients with:

4.4.a.1. aortic coarctation; (Core)

4.4.a.2. atrial arrhythmias associated with congenital heart disease; (Core)

4.4.a.3. atrial septal defects (secundum, primum, venosus); (Core)

4.4.a.4. atrioventricular defects; (Core)

4.4.a.5. bicommissural and unicommissural aortic valve; (Core)

4.4.a.6. congenital abnormalities of left-sided inflow, including pulmonary vein disease, cor triatriatum, and mitral valve abnormalities; (Core)

4.4.a.7. congenital coronary anomalies; (Core)

4.4.a.8. D-transposition of the great arteries with arterial switch repair; (Core)

4.4.a.9. D-transposition of the great arteries with atrial switch repair (Senning, Mustard); (Core)

4.4.a.10. Ebstein anomaly; (Core)



- 4.4.a.11. Eisenmenger syndrome and pulmonary hypertension associated with congenital heart disease; (Core)
- 4.4.a.12. heart failure (including mechanical circulatory support and transplantation) associated with congenital heart disease; (Core)
- 4.4.a.13. L-transposition of the great arteries; (Core)
- 4.4.a.14. patent ductus arteriosus; (Core)
- 4.4.a.15. pregnancy associated with maternal congenital heart disease; (Core)
- 4.4.a.16. pulmonary stenosis (subvalvular, valvular, supra-valvular, and peripheral pulmonary stenosis); (Core)
- 4.4.a.17. single ventricle anatomy (double outlet right ventricle, double inlet left ventricle, pulmonary atresia, hypoplastic left ventricle, tricuspid atresia); (Core)
- 4.4.a.18. subvalvular aortic stenosis; (Core)
- 4.4.a.19. supra-valvular aortic stenosis; (Core)
- 4.4.a.20. syndrome-associated and inherited forms of congenital heart and vascular disease (including Down, Williams, Turner, Noonan, Marfan); (Core)
- 4.4.a.21. tetralogy of Fallot; (Core)
- 4.4.a.22. tetralogy of Fallot with pulmonary atresia; (Core)
- 4.4.a.23. ventricular arrhythmias associated with congenital heart disease; and, (Core)
- 4.4.a.24. ventricular septal defects. (Core)

#### **4.5. ACGME Competencies – Procedural Skills**

**Fellows must be able to perform all medical, diagnostic, and surgical procedures considered essential for the area of practice. (Core)**

- 4.5.a. Fellows must demonstrate competence in the ability to perform diagnostic and therapeutic procedures relevant to their specific career paths. (Core)
- 4.5.b. Fellows must demonstrate competence in the ability to treat their patients' conditions with practice that are patient-centered, safe, scientifically based, effective, timely, and cost-effective. (Core)
- 4.5.c. Fellows must demonstrate competence in the ability to participate in pre-procedural planning, including the indications for a procedure, and the selection of the appropriate sedation and anesthetic agents, procedures, or instruments. (Core)

- 4.5.d. Fellows must demonstrate competence in the ability to provide post-procedure care. (Core)
- 4.5.e. Fellows must demonstrate competence in ACHD evaluation, to include applying and interpreting approaches to evaluating symptom severity, functional capacity, and health-related quality of life in adult patients with congenital heart disease. (Core)
- 4.5.f. Fellows must demonstrate competence in ACHD evaluation, to include recognizing clinical features in all forms and etiologies of congenital heart disease. (Core)
- 4.5.g. Fellows must demonstrate competence in ACHD evaluation, to include recognizing the indications for, understanding the complications with, and interpreting the results of all diagnostic tests and modalities relevant to evaluating and managing patients with or suspected of having congenital heart disease; in particular, recognizing the impact of such testing on the management of these patients, including: (Core)
  - 4.5.g.1. transthoracic ACHD echocardiography; (Core)
  - 4.5.g.2. transesophageal ACHD echocardiography; and, (Core)
  - 4.5.g.3. diagnostic catheterization. (Core)
- 4.5.h. Fellows must demonstrate competence in ACHD management, including determining timing and methods of surveillance for each lesion. (Core)
- 4.5.i. Fellows must demonstrate competence in ACHD management, including surveillance, diagnosis, and both medical and mechanical management of atrial and ventricular arrhythmias in the unoperated and post-operative state. (Core)
- 4.5.j. Fellows must demonstrate competence in ACHD management, including surveillance, diagnosis, and both medical and mechanical management of heart block and conduction abnormalities in the unoperated and post-operative state. (Core)
- 4.5.k. Fellows must demonstrate competence in ACHD management, including recognizing the indications for and prescribing non-pharmacologic, non-device treatment modalities, including diet and exercise. (Core)
- 4.5.l. Fellows must demonstrate competence in ACHD management, including recognizing the indications for, prescribing, and monitoring all classes of drugs relevant to patient care. (Core)
- 4.5.m. Fellows must demonstrate competence in ACHD management, including recognizing the indications for, understanding the complications of, and interpreting the results of all interventional modalities relevant to managing patients with or suspected of having congenital heart disease; in particular, recognizing the impact of such interventions on the management of these patients, including: (Core)

- 4.5.m.1. interventional catheterization; (Core)
- 4.5.m.2. cardiac or electrophysiologic procedural interventions and cardiovascular surgery; (Core)
- 4.5.m.3. non-cardiac surgery; and, (Core)
- 4.5.m.4. pregnancy. (Core)

**4.6. ACGME Competencies – Medical Knowledge**

**Fellows must demonstrate knowledge of established and evolving biomedical, clinical, epidemiological and social-behavioral sciences, including scientific inquiry, as well as the application of this knowledge to patient care. (Core)**

- 4.6.a. Fellows must demonstrate knowledge of indications and contraindications of, limitations and complications with, techniques for, and interpretation of results from those diagnostic and therapeutic procedures, integral to the discipline, to include the appropriate indications for and use of screening tests/procedures, including:
  - electrocardiogram (EKG) and electrophysiologic testing and intervention;
  - cardiopulmonary function assessment and exercise testing;
  - transthoracic echocardiography (TTE) and transesophageal echocardiography (TEE); cardiac and vascular computed tomography (CT) and magnetic resonance imaging (MRI);
  - hemodynamics and catheterization-based imaging and intervention; and,
  - surgeries, including peri-operative and procedure-related anesthetics and mechanical cardiopulmonary support techniques. (Core)
- 4.6.b. Fellows must demonstrate knowledge of basic mechanisms underlying each type of cardiac anomaly as delineated under “Patient Care” above, including:
  - 4.6.b.1. childhood palliative and complete surgical and interventional repairs, including the associated intermediate- and longer-term outcomes, for each type of anomaly; (Core)
  - 4.6.b.2. differential diagnosis that includes specific etiologies of and exacerbating factors for each type of anomaly; (Core)
  - 4.6.b.3. expected presenting symptoms, physical examination, and cardiac conduction findings for each type of anomaly; (Core)
  - 4.6.b.4. genetics, to include common mutations leading to congenital heart disease; (Core)
  - 4.6.b.5. guidelines-specific recommendations regarding diagnosis and management of each type of anomaly; (Core)

- 4.6.b.6. the impact of age- and development-specific chronic disease skills and psychosocial factors on the manifestation, expression, and management of ACHD across the lifespan of disease; (Core)
- 4.6.b.7. important genetic associations specific to each individual type of anomaly, particularly as related to outcomes; (Core)
- 4.6.b.8. lesion- and repair-specific effects on pregnancy and maternal health risk and interventions, and potential complications; (Core)
- 4.6.b.9. lesion- and repair-specific, intermediate- and longer-term effects on myocardial function; (Core)
- 4.6.b.10. principles of cardiac development and anatomy in unrepaired and repaired states for each type of anomaly; (Core)
- 4.6.b.11. principles of physiology in unrepaired and repaired states for each type of anomaly; and, (Core)
- 4.6.b.12. important genetic associations specific to each individual type of anomaly, particularly as related to outcomes. (Core)

**4.7. ACGME Competencies – Practice-Based Learning and Improvement**  
**Fellows must demonstrate the ability to investigate and evaluate their care of patients, to appraise and assimilate scientific evidence, and to continuously improve patient care based on constant self-evaluation and lifelong learning.** (Core)

**4.8. ACGME Competencies – Interpersonal and Communication Skills**  
**Fellows must demonstrate interpersonal and communication skills that result in the effective exchange of information and collaboration with patients, their families, and health professionals.** (Core)

**4.9. ACGME Competencies – Systems-Based Practice**  
**Fellows must demonstrate an awareness of and responsiveness to the larger context and system of health care, including the structural and social determinants of health, as well as the ability to call effectively on other resources to provide optimal health care.** (Core)

**4.10. Curriculum Organization and Fellow Experiences – Curriculum Structure**  
**The curriculum must be structured to optimize fellow educational experiences, the length of the experiences, and the supervisory continuity. These educational experiences include an appropriate blend of supervised patient care responsibilities, clinical teaching, and didactic educational events.** (Core)

4.10.a. Rotations must be of a sufficient length to provide longitudinal relationships with faculty members to allow for meaningful assessment and feedback. (Core)

4.10.b. Rotations must be structured to allow fellows to function as part of an effective interprofessional team that works together towards the shared goals of patient safety and quality improvement. (Core)

4.10.c. Schedules must be structured to minimize conflicting inpatient and outpatient responsibilities. (Core)

**4.11. Curriculum Organization and Fellow Experiences – Didactic and Clinical Experiences**

**Fellows must be provided with protected time to participate in core didactic activities. (Core)**

4.11.a. Required clinical experiences may be organized as a defined block or a longitudinal experience, and must include: (Core)

4.11.a.1. at least nine months of inpatient or consultative service that provides comprehensive care for ACHD patients; (Core)

4.11.a.2. at least three months of comprehensive diagnostic and interventional services and imaging (transthoracic echocardiography, transesophageal echocardiography, cardiac computed tomography angiography and cardiac magnetic resonance imaging) for ACHD patients; (Core)

4.11.a.3. at least two months of ACHD catheterization (diagnostic and interventional), including experience in the limits and applications of measurements and definition of vascular resistance and flows, pressure gradients, and optimal correlation of angiography with physiologic measures and additional imaging modalities; (Core)

4.11.a.4. at least one month of intensive care and surgical services that provide comprehensive care for patients, including experience in the optimal transition from pre- to intra- to post-operative care environments, as well as development, provision, and communication of care plans through short-, intermediate- and longer-term post-operative follow-up; (Core)

4.11.a.5. experience on pediatric, internal medicine, or cardiology services that expand understanding of the multiple organ system and the behavioral and psychosocial ramifications of congenital heart disease over the course of a patient's lifetime; (Core)

4.11.a.5.a. For the fellow entering with subspecialty education in adult cardiovascular disease, this must include at least three months dedicated to a combination of pediatric medicine, adolescent medicine, transition medicine, and pediatric cardiology. (Core)

4.11.a.5.b. For the fellow entering with residency education in internal medicine-pediatrics and subspecialty education in pediatric cardiology, this must

include at least three months dedicated to a combination of internal medicine, transition medicine, and adult cardiology. (Core)

- 4.11.a.5.c. For the fellow entering with residency education in pediatrics and subspecialty education in pediatric cardiology, this must include:
- 4.11.a.5.c.1. at least three months of internal medicine; (Core)
  - 4.11.a.5.c.2. at least three months of adult cardiology; and, (Core)
  - 4.11.a.5.c.3. attestation of education in the competencies in internal medicine care. (Core)
- 4.11.a.6. caring for patients in the context of a multidisciplinary disease management program; (Core)
- 4.11.a.7. end-of-life care; (Core)
- 4.11.a.8. evaluating patients for cardiac or pulmonary transplantation or mechanical assist devices; (Core)
- 4.11.a.9. a continuity ambulatory clinic that exposes the fellows to the breadth and depth of ACHD. (Core)
- 4.11.a.9.a. This experience should average at least one half day each week. (Detail)
  - 4.11.a.9.b. This experience must include an appropriate distribution of patients of each gender and a diversity of ages, with attention to age-, gender-, or ethnicity-based differences in disease or care disparities when such occur. (Core)
  - 4.11.a.9.c. Each fellow should, on average, be responsible for at least three patients during each half-day session. (Detail)
  - 4.11.a.9.d. The continuity patient care experience should not be interrupted by more than one month, excluding a fellow's vacation. (Detail)
- 4.11.b. The educational program must provide fellows with individualized educational experiences to allow them to participate in opportunities relevant to their future practice or to further skill/competence development in the foundational educational experiences of the subspecialty. (Core)

Subspecialty-Specific Background and Intent: The Review Committee recognizes there are circumstances when didactic instruction in ACHD is provided through combined conferences with the parent cardiovascular disease or other cardiovascular disease sub-subspecialties (e.g., interventional cardiology, clinical cardiac electrophysiology) fellowship's conferences. When this occurs, it would be appropriate for:

- all fellows to attend the same conferences, not just when ACHD topics are discussed;

- core faculty members from the ACHD fellowship attend the conferences and,
- topics in the ACHD fellowship area to be regularly discussed and fellows to discuss recent literature in the ACHD area.

4.11.c. Required Didactic Experience

The educational program must include didactic instruction based upon the core knowledge content in the subspecialty area. (Core)

Subspecialty-Specific Background and Intent: The Review Committee recognizes there are circumstances when didactic instruction in ACHD is provided through combined conferences with the parent cardiovascular disease or other cardiovascular disease sub-subspecialties (e.g., interventional cardiology, clinical cardiac electrophysiology) fellowship's conferences. When this occurs, it would be appropriate for:

- all fellows to attend the same conferences, not just when ACHD topics are discussed;
- core faculty members from the ACHD fellowship attend the conferences and,
- topics in the ACHD fellowship area to be regularly discussed and fellows to discuss recent literature in the ACHD area.

4.11.c.1. The program must ensure that fellows have an opportunity to review all content from conferences that they could not attend. (Core)

Subspecialty-Specific Background and Intent: Core content presented during conferences will need to be available for fellows who missed the conference. This can include repeating the conference, recording and making it available electronically, or otherwise sharing the content from the conference electronically.

4.11.c.2. Fellows must have a sufficient number of didactic sessions to ensure fellow-fellow and fellow-faculty interaction. (Core)

4.11.d. Direct supervision of procedures performed by each fellow must occur until proficiency has been acquired and documented by the program director. (Core)

4.11.e. Faculty members must teach and supervise the fellows in the performance and interpretation of procedures, which must be documented in each fellow's record, including indications, outcomes, diagnoses, and supervisor(s). (Core)

4.11.f. Fellows should be instructed in practice management relevant to the subspecialty. (Detail)

Subspecialty-Specific Background and Intent: Instruction in practice management can include the organization and financing of clinical practice, including personnel and business

management, scheduling, billing and coding procedures, telephone and telemedicine management, and maintenance of an appropriate confidential patient record system.

#### **4.12. Curriculum Organization and Fellow Experiences – Pain Management**

The program must provide instruction and experience in pain management if applicable for the subspecialty, including recognition of the signs of substance use disorder. (Core)

#### **Scholarship**

*Medicine is both an art and a science. The physician is a humanistic scientist who cares for patients. This requires the ability to think critically, evaluate the literature, appropriately assimilate new knowledge, and practice lifelong learning. The program and faculty must create an environment that fosters the acquisition of such skills through fellow participation in scholarly activities as defined in the subspecialty-specific Program Requirements. Scholarly activities may include discovery, integration, application, and teaching.*

*The ACGME recognizes the diversity of fellowships and anticipates that programs prepare physicians for a variety of roles, including clinicians, scientists, and educators. It is expected that the program's scholarship will reflect its mission(s) and aims, and the needs of the community it serves. For example, some programs may concentrate their scholarly activity on quality improvement, population health, and/or teaching, while other programs might choose to utilize more classic forms of biomedical research as the focus for scholarship.*

#### **4.13. Program Responsibilities**

The program must demonstrate evidence of scholarly activities, consistent with its mission(s) and aims. (Core)

#### **4.14. Faculty Scholarly Activity**

The faculty must establish and maintain an environment of inquiry and scholarship with an active research component. (Core)

4.14.a. The faculty must regularly participate in organized clinical discussions, rounds, journal clubs, and conferences. (Detail)

4.14.b. At least 50 percent of the core faculty members who are ABIM-certified in adult congenital heart disease by the ABIM (see Program Requirements 2.10.b.-c. must annually engage in a variety of scholarly activities from among the following: faculty participation in grand rounds; posters; workshops; quality improvement presentations; podium presentations; grant leadership; non-peer-reviewed print/electronic resources; articles or publications; book chapters; textbooks; webinars; service on professional committees; or serving as a journal reviewer, journal editorial board member, or editor. (Core)

#### **4.15. Fellow Scholarly Activity**

While in the program, all fellows must engage in at least one of the following scholarly activities: participation in grand rounds, posters, workshops, quality



improvement presentations, podium presentations, grant leadership, non-peer-reviewed print/electronic resources, articles or publications, book chapters, textbooks, webinars, service on professional committees, or serving as a journal reviewer, journal editorial board member, or editor. (Outcome)

## Section 5: Evaluation

### 5.1. Fellow Evaluation: Feedback and Evaluation

**Faculty members must directly observe, evaluate, and frequently provide feedback on fellow performance during each rotation or similar educational assignment. (Core)**

**Background and Intent: Feedback is ongoing information provided regarding aspects of one's performance, knowledge, or understanding. The faculty empower fellows to provide much of that feedback themselves in a spirit of continuous learning and self-reflection. Feedback from faculty members in the context of routine clinical care should be frequent, and need not always be formally documented.**

**Formative and summative evaluation have distinct definitions. Formative evaluation is *monitoring fellow learning* and providing ongoing feedback that can be used by fellows to improve their learning in the context of provision of patient care or other educational opportunities. More specifically, formative evaluations help:**

- **fellows identify their strengths and weaknesses and target areas that need work**
- **program directors and faculty members recognize where fellows are struggling and address problems immediately**

**Summative evaluation is *evaluating a fellow's learning* by comparing the fellows against the goals and objectives of the rotation and program, respectively. Summative evaluation is utilized to make decisions about promotion to the next level of training, or program completion.**

**End-of-rotation and end-of-year evaluations have both summative and formative components. Information from a summative evaluation can be used formatively when fellows or faculty members use it to guide their efforts and activities in subsequent rotations and to successfully complete the fellowship program.**

**Feedback, formative evaluation, and summative evaluation compare intentions with accomplishments, enabling the transformation of a new specialist to one with growing subspecialty expertise.**

**Background and Intent: Faculty members should provide feedback frequently throughout the course of each rotation. Fellows require feedback from faculty members to reinforce well-performed duties and tasks, as well as to correct deficiencies. This**

feedback will allow for the development of the learner as they strive to achieve the Milestones. More frequent feedback is strongly encouraged for fellows who have deficiencies that may result in a poor final rotation evaluation.

- 5.1.a. Evaluation must be documented at the completion of the assignment. (Core)
- 5.1.a.1. Evaluations must be completed at least every three months. (Core)
- 5.1.b. The program must provide an objective performance evaluation based on the Competencies and the subspecialty-specific Milestones, and must: (Core)
  - 5.1.b.1. use multiple evaluators (e.g., faculty members, peers, patients, self, and other professional staff members); and, (Core)
  - 5.1.b.2. provide that information to the Clinical Competency Committee for its synthesis of progressive fellow performance and improvement toward unsupervised practice. (Core)

**Background and Intent:** The trajectory to autonomous practice in a subspecialty is documented by the subspecialty-specific Milestones evaluation during fellowship. These Milestones detail the progress of a fellow in attaining skill in each competency domain. It is expected that the most growth in fellowship education occurs in patient care and medical knowledge, while the other four domains of competency must be ensured in the context of the subspecialty. They are developed by a subspecialty group and allow evaluation based on observable behaviors. The Milestones are considered formative and should be used to identify learning needs. This may lead to focused or general curricular revision in any given program or to individualized learning plans for any specific fellow.

- 5.1.c. The program director or their designee, with input from the Clinical Competency Committee, must meet with and review with each fellow their documented semi-annual evaluation of performance, including progress along the subspecialty-specific Milestones. (Core)
- 5.1.d. The program director or their designee, with input from the Clinical Competency Committee, must develop plans for fellows failing to progress, following institutional policies and procedures. (Core)

**Background and Intent:** Learning is an active process that requires effort from the teacher and the learner. Faculty members evaluate a fellow's performance at least at the end of each rotation. The program director or their designee will review those evaluations, including their progress on the Milestones, at a minimum of every six months. Fellows should be encouraged to reflect upon the evaluation, using the information to reinforce well-performed tasks or knowledge or to modify deficiencies in knowledge or practice. Working together with the faculty members, fellows should develop an individualized learning plan.

**Fellows who are experiencing difficulties with achieving progress along the Milestones may require intervention to address specific deficiencies. Such intervention, documented in an individual remediation plan developed by the program director or a faculty mentor and the fellow, will take a variety of forms based on the specific learning needs of the fellow. However, the ACGME recognizes that there are situations which require more significant intervention that may alter the time course of fellow progression. To ensure due process, it is essential that the program director follow institutional policies and procedures.**

- 5.1.e. The evaluations of a fellow’s performance must be accessible for review by the fellow. (Core)**
- 5.1.f. Assessment of procedural competence should include a formal evaluation process and not be based solely on a minimum number of procedures performed. (Core)
- 5.2. Fellow Evaluation: Final Evaluation**  
**The program director must provide a final evaluation for each fellow upon completion of the program. (Core)**
- 5.2.a. The subspecialty-specific Milestones, and when applicable the subspecialty-specific Case Logs, must be used as tools to ensure fellows are able to engage in autonomous practice upon completion of the program. (Core)
- 5.2.b. The final evaluation must become part of the fellow’s permanent record maintained by the institution, and must be accessible for review by the fellow in accordance with institutional policy. (Core)
- 5.2.c. The final evaluation must verify that the fellow has demonstrated the knowledge, skills, and behaviors necessary to enter autonomous practice. (Core)
- 5.2.d. The final evaluation must be shared with the fellow upon completion of the program. (Core)
- 5.3. Clinical Competency Committee**  
**A Clinical Competency Committee must be appointed by the program director. (Core)**
- 5.3.a. At a minimum the Clinical Competency Committee must include three members, at least one of whom is a core faculty member. Members must be faculty members from the same program or other programs, or other health professionals who have extensive contact and experience with the program’s fellows. (Core)

**Background and Intent: The requirements regarding the Clinical Competency Committee do not preclude or limit a program director’s participation on the Clinical Competency Committee. The intent is to leave flexibility for each program to decide**

the best structure for its own circumstances, but a program should consider: its program director's other roles as fellow advocate, advisor, and confidante; the impact of the program director's presence on the other Clinical Competency Committee members' discussions and decisions; the size of the program faculty; and other program-relevant factors. Inclusivity is an important consideration in the appointment of Clinical Competency Committee members, ensuring diverse participation to achieve fair evaluation. The program director has final responsibility for fellow evaluation and promotion decisions.

The program faculty may include more than the physician faculty members, such as other physicians and non-physicians who teach and evaluate the program's fellows. There may be additional members of the Clinical Competency Committee.

- 5.3.b. The Clinical Competency Committee must review all fellow evaluations at least semi-annually. *(Core)*
- 5.3.c. The Clinical Competency Committee must determine each fellow's progress on achievement of the subspecialty-specific Milestones. *(Core)*
- 5.3.d. The Clinical Competency Committee must meet prior to the fellows' semi-annual evaluations and advise the program director regarding each fellow's progress. *(Core)*
- 5.4. **Faculty Evaluation**  
The program must have a process to evaluate each faculty member's performance as it relates to the educational program at least annually. *(Core)*

**Background and Intent:** The program director is responsible for the educational program and for all educators. While the term "faculty" may be applied to physicians within a given institution for other reasons, it is applied to fellowship program faculty members only through approval by a program director. The development of the faculty improves the education, clinical, and research aspects of a program. Faculty members have a strong commitment to the fellow and desire to provide optimal education and work opportunities. Faculty members must be provided feedback on their contribution to the mission of the program. All faculty members who interact with fellows desire feedback on their education, clinical care, and research. If a faculty member does not interact with fellows, feedback is not required. With regard to the diverse operating environments and configurations, the fellowship program director may need to work with others to determine the effectiveness of the program's faculty performance with regard to their role in the educational program. All teaching faculty members should have their educational efforts evaluated by the fellows in a confidential and anonymous manner. Other aspects for the feedback may include research or clinical productivity, review of patient outcomes, or peer review of scholarly activity. The process should reflect the local environment and identify the necessary information. The feedback from

**the various sources should be summarized and provided to the faculty on an annual basis by a member of the leadership team of the program.**

- 5.4.a. This evaluation must include a review of the faculty member’s clinical teaching abilities, engagement with the educational program, participation in faculty development related to their skills as an educator, clinical performance, professionalism, and scholarly activities. (Core)**
- 5.4.b. This evaluation must include written, confidential evaluations by the fellows. (Core)**
- 5.4.c. Faculty members must receive feedback on their evaluations at least annually. (Core)**

**Background and Intent: The quality of the faculty’s teaching and clinical care is a determinant of the quality of the program and the quality of the fellows’ future clinical care. Therefore, the program has the responsibility to evaluate and improve the program faculty members’ teaching, scholarship, professionalism, and quality care. This section mandates annual review of the program’s faculty members for this purpose, and can be used as input into the Annual Program Evaluation.**

- 5.5. Program Evaluation and Improvement**  
**The program director must appoint the Program Evaluation Committee to conduct and document the Annual Program Evaluation as part of the program’s continuous improvement process. (Core)**
- 5.5.a. The Program Evaluation Committee must be composed of at least two program faculty members, at least one of whom is a core faculty member, and at least one fellow. (Core)**
- 5.5.b. Program Evaluation Committee responsibilities must include review of the program’s self-determined goals and progress toward meeting them. (Core)**
- 5.5.c. Program Evaluation Committee responsibilities must include guiding ongoing program improvement, including development of new goals, based upon outcomes. (Core)**
- 5.5.d. Program Evaluation Committee responsibilities must include review of the current operating environment to identify strengths, challenges, opportunities, and threats as related to the program’s mission and aims. (Core)**

**Background and Intent: To achieve its mission and educate and train quality physicians, a program must evaluate its performance and plan for improvement in the Annual Program Evaluation. Performance of fellows and faculty members is a reflection of program quality, and can use metrics that reflect the goals that a program has set for itself. The Program Evaluation Committee utilizes outcome parameters and other data to**

assess the program's progress toward achievement of its goals and aims. The Program Evaluation Committee advises the program director through program oversight.

- 5.5.e. The Program Evaluation Committee should consider the outcomes from prior Annual Program Evaluation(s), aggregate fellow and faculty written evaluations of the program, and other relevant data in its assessment of the program. (Core)

Background and Intent: Other data to be considered for assessment include:

- Fellow performance
- Faculty development
- Progress on the previous year's action plan(s)

- 5.5.f. The Program Evaluation Committee must evaluate the program's mission and aims, strengths, areas for improvement, and threats. (Core)

- 5.5.g. The Annual Program Evaluation, including the action plan, must be distributed to and discussed with the members of the teaching faculty and the fellows, and be submitted to the DIO. (Core)

- 5.5.h. The program must participate in a Self-Study and submit it to the DIO. (Core)

#### Board Certification

*One goal of ACGME-accredited education is to educate physicians who seek and achieve board certification. One measure of the effectiveness of the educational program is the ultimate pass rate.*

*The program director should encourage all eligible program graduates to take the certifying examination offered by the applicable American Board of Medical Specialties (ABMS) member board or American Osteopathic Association (AOA) certifying board.*

[Note that there is no AOA board certification in this subspecialty.]

#### 5.6. Board Certification

For subspecialties in which the ABMS member board and/or AOA certifying board offer(s) an annual written exam, in the preceding three years, the program's aggregate pass rate of those taking the examination for the first time must be higher than the bottom fifth percentile of programs in that subspecialty. (Outcome)

- 5.6.a. For subspecialties in which the ABMS member board and/or AOA certifying board offer(s) a biennial written exam, in the preceding six years, the program's aggregate pass rate of those taking the examination for the first time must be higher than the bottom fifth percentile of programs in that subspecialty. (Outcome)

- 5.6.b. For subspecialties in which the ABMS member board and/or AOA certifying board offer(s) an annual oral exam, in the preceding three years, the program’s aggregate pass rate of those taking the examination for the first time must be higher than the bottom fifth percentile of programs in that subspecialty. (Outcome)
- 5.6.c. For subspecialties in which the ABMS member board and/or AOA certifying board offer(s) a biennial oral exam, in the preceding six years, the program’s aggregate pass rate of those taking the examination for the first time must be higher than the bottom fifth percentile of programs in that subspecialty. (Outcome)
- 5.6.d. For each of the exams referenced in 5.6. – 5.6.c., any program whose graduates over the time period specified in the requirement have achieved an 80 percent pass rate will have met this requirement, no matter the percentile rank of the program for pass rate in that subspecialty. (Outcome)

**Background and Intent:** Setting a single standard for pass rate that works across subspecialties is not supportable based on the heterogeneity of the psychometrics of different examinations. By using a percentile rank, the performance of the lower five percent (fifth percentile) of programs can be identified and set on a path to curricular and test preparation reform.

There are subspecialties where there is a very high board pass rate that could leave successful programs in the bottom five percent (fifth percentile) despite admirable performance. These high-performing programs should not be cited, and 5.6.d. is designed to address this.

- 5.6.e. Programs must report, in ADS, board certification status annually for the cohort of board-eligible fellows that graduated seven years earlier. (Core)

**Background and Intent:** It is essential that fellowship programs demonstrate knowledge and skill transfer to their fellows. One measure of that is the qualifying or initial certification exam pass rate. Another important parameter of the success of the program is the ultimate board certification rate of its graduates. Graduates are eligible for up to seven years from fellowship graduation for initial certification. The ACGME will calculate a rolling three-year average of the ultimate board certification rate at seven years post-graduation, and the Review Committees will monitor it.

The Review Committees will track the rolling seven-year certification rate as an indicator of program quality. Programs are encouraged to monitor their graduates’ performance on board certification examinations.

In the future, the ACGME may establish parameters related to ultimate board certification rates.

## Section 6: The Learning and Working Environment

*Fellowship education must occur in the context of a learning and working environment that emphasizes the following principles:*

- *Excellence in the safety and quality of care rendered to patients by fellows today*
- *Excellence in the safety and quality of care rendered to patients by today's fellows in their future practice*
- *Excellence in professionalism*
- *Appreciation for the privilege of providing care for patients*
- *Commitment to the well-being of the students, residents, fellows, faculty members, and all members of the health care team*

### **Culture of Safety**

*A culture of safety requires continuous identification of vulnerabilities and a willingness to transparently deal with them. An effective organization has formal mechanisms to assess the knowledge, skills, and attitudes of its personnel toward safety in order to identify areas for improvement.*

- 6.1. The program, its faculty, residents, and fellows must actively participate in patient safety systems and contribute to a culture of safety. (Core)

### **Patient Safety Events**

*Reporting, investigation, and follow-up of safety events, near misses, and unsafe conditions are pivotal mechanisms for improving patient safety, and are essential for the success of any patient safety program. Feedback and experiential learning are essential to developing true competence in the ability to identify causes and institute sustainable systems-based changes to ameliorate patient safety vulnerabilities.*

- 6.2. Residents, fellows, faculty members, and other clinical staff members must know their responsibilities in reporting patient safety events and unsafe conditions at the clinical site, including how to report such events. (Core)
- 6.2.a. Residents, fellows, faculty members, and other clinical staff members be provided with summary information of their institution's patient safety reports. (Core)
- 6.3. Fellows must participate as team members in real and/or simulated interprofessional clinical patient safety and quality improvement activities, such as root cause analyses or other activities that include analysis, as well as formulation and implementation of actions. (Core)

### **Quality Metrics**

*Access to data is essential to prioritizing activities for care improvement and evaluating success of improvement efforts.*



- 6.4. Fellows and faculty members must receive data on quality metrics and benchmarks related to their patient populations. (Core)

#### **Supervision and Accountability**

*Although the attending physician is ultimately responsible for the care of the patient, every physician shares in the responsibility and accountability for their efforts in the provision of care. Effective programs, in partnership with their Sponsoring Institutions, define, widely communicate, and monitor a structured chain of responsibility and accountability as it relates to the supervision of all patient care.*

*Supervision in the setting of graduate medical education provides safe and effective care to patients; ensures each fellow's development of the skills, knowledge, and attitudes required to enter the unsupervised practice of medicine; and establishes a foundation for continued professional growth.*

- 6.5. Fellows and faculty members must inform each patient of their respective roles in that patient's care when providing direct patient care. (Core)
- 6.5.a. This information must be available to fellows, faculty members, other members of the health care team, and patients. (Core)

**Background and Intent:** Each patient will have an identifiable and appropriately credentialed and privileged attending physician (or licensed independent practitioner as specified by the applicable Review Committee) who is responsible and accountable for the patient's care.

- 6.6. The program must demonstrate that the appropriate level of supervision in place for all fellows is based on each fellow's level of training and ability, as well as patient complexity and acuity. Supervision may be exercised through a variety of methods, as appropriate to the situation. (Core)

**Background and Intent:** Appropriate supervision is essential for patient safety and high-quality teaching. Supervision is also contextual. There is tremendous diversity of fellow-patient interactions, training locations, and fellow skills and abilities, even at the same level of the educational program. The degree of supervision is expected to evolve progressively as a fellow gains more experience, even with the same patient condition or procedure. The level of supervision for each fellow is commensurate with that fellow's level of independence in practice; this level of supervision may be enhanced based on factors such as patient safety, complexity, acuity, urgency, risk of serious safety events, or other pertinent variables.

#### **Levels of Supervision**

*To promote appropriate fellow supervision while providing for graded authority and responsibility, the program must use the following classification of supervision.*

- 6.7. **Direct Supervision**  
*The supervising physician is physically present with the fellow during the key portions of the patient interaction.*

*The supervising physician and/or patient is not physically present with the fellow and the supervising physician is concurrently monitoring the patient care through appropriate telecommunication technology.*

#### **Indirect Supervision**

*The supervising physician is not providing physical or concurrent visual or audio supervision but is immediately available to the fellow for guidance and is available to provide appropriate direct supervision.*

#### **Oversight**

*The supervising physician is available to provide review of procedures/encounters with feedback provided after care is delivered.*

- 6.8. The program must define when physical presence of a supervising physician is required. (Core)
- 6.9. The privilege of progressive authority and responsibility, conditional independence, and a supervisory role in patient care delegated to each fellow must be assigned by the program director and faculty members. (Core)
  - 6.9.a. The program director must evaluate each fellow's abilities based on specific criteria, guided by the Milestones. (Core)
  - 6.9.b. Faculty members functioning as supervising physicians must delegate portions of care to fellows based on the needs of the patient and the skills of each fellow. (Core)
  - 6.9.c. Fellows should serve in a supervisory role to junior fellows and residents in recognition of their progress toward independence, based on the needs of each patient and the skills of the individual resident or fellow. (Detail)
- 6.10. Programs must set guidelines for circumstances and events in which fellows must communicate with the supervising faculty member(s). (Core)
  - 6.10.a. Each fellow must know the limits of their scope of authority, and the circumstances under which the fellow is permitted to act with conditional independence. (Outcome)

**Background and Intent: The ACGME Glossary of Terms defines conditional independence as: Graded, progressive responsibility for patient care with defined oversight.**

- 6.11. Faculty supervision assignments must be of sufficient duration to assess the knowledge and skills of each fellow and to delegate to the fellow the appropriate level of patient care authority and responsibility. (Core)
- 6.12. **Professionalism**  
Programs, in partnership with their Sponsoring Institutions, must educate fellows and faculty members concerning the professional and ethical responsibilities of

physicians, including but not limited to their obligation to be appropriately rested and fit to provide the care required by their patients. (Core)

**Background and Intent:** This requirement emphasizes the professional responsibility of fellows and faculty members to arrive for work adequately rested and ready to care for patients. It is also the responsibility of fellows, faculty members, and other members of the care team to be observant, to intervene, and/or to escalate their concern about fellow and faculty member fitness for work, depending on the situation, and in accordance with institutional policies. This includes recognition of impairment, including from illness, fatigue, and substance use, in themselves, their peers, and other members of the health care team, and the recognition that under certain circumstances, the best interests of the patient may be served by transitioning that patient's care to another qualified and rested practitioner.

**6.12.a.** The learning objectives of the program must be accomplished without excessive reliance on fellows to fulfill non-physician obligations. (Core)

**Background and Intent:** Routine reliance on fellows to fulfill non-physician obligations increases work compression for fellows and does not provide an optimal educational experience. Non-physician obligations are those duties which in most institutions are performed by nursing and allied health professionals, transport services, or clerical staff. Examples of such obligations include transport of patients from the wards or units for procedures elsewhere in the hospital; routine blood drawing for laboratory tests; routine monitoring of patients when off the ward; and clerical duties, such as scheduling. While it is understood that fellows may be expected to do any of these things on occasion when the need arises, these activities should not be performed by fellows routinely and must be kept to a minimum to optimize fellow education.

**6.12.b.** The learning objectives of the program must ensure manageable patient care responsibilities. (Core)

**Background and Intent:** The Common Program Requirements do not define "manageable patient care responsibilities" as this is variable by specialty/subspecialty and PGY level. Review Committees will provide further detail regarding patient care responsibilities in the applicable specialty- and subspecialty-specific Program Requirements and accompanying FAQs. However, all programs, regardless of specialty/subspecialty, should carefully assess how the assignment of patient care responsibilities can affect work compression.

**6.12.c.** The learning objectives of the program must include efforts to enhance the meaning that each fellow finds in the experience of being a physician, including protecting time with patients, providing administrative support, promoting progressive independence and flexibility, and enhancing professional relationships. (Core)

- 6.12.d. The program director, in partnership with the Sponsoring Institution, must provide a culture of professionalism that supports patient safety and personal responsibility. (Core)

**Background and Intent:** The accurate reporting of clinical and educational work hours, patient outcomes, and clinical experience data are the responsibility of the program leadership, fellows, and faculty.

- 6.12.e. Fellows and faculty members must demonstrate an understanding of their personal role in the safety and welfare of patients entrusted to their care, including the ability to report unsafe conditions and safety events. (Core)
- 6.12.f. Programs, in partnership with their Sponsoring Institutions, must provide a professional, equitable, respectful, and civil environment that is psychologically safe and that is free from discrimination, sexual and other forms of harassment, mistreatment, abuse, or coercion of students, fellows, faculty, and staff. (Core)

**Background and Intent:** Psychological safety is defined as an environment of trust and respect that allows individuals to feel able to ask for help, admit mistakes, raise concerns, suggest ideas, and challenge ways of working and the ideas of others on the team, including the ideas of those in authority, without fear of humiliation, and the knowledge that mistakes will be handled justly and fairly.

The ACGME is unable to adjudicate disputes between individuals, including residents, faculty members, and staff members. However, information that suggests a pattern of behavior that violates the requirement above will trigger a careful review and, if deemed appropriate, action by the Review Committee and/or ACGME, in accordance with ACGME Policies and Procedures.

- 6.12.g. Programs, in partnership with their Sponsoring Institutions, should have a process for education of fellows and faculty regarding unprofessional behavior and a confidential process for reporting, investigating, and addressing such concerns. (Core)

### **Well-Being**

***Psychological, emotional, and physical well-being are critical in the development of the competent, caring, and resilient physician and require proactive attention to life inside and outside of medicine. Well-being requires that physicians retain the joy in medicine while managing their own real-life stresses. Self-care and responsibility to support other members of the health care team are important components of professionalism; they are also skills that must be modeled, learned, and nurtured in the context of other aspects of fellowship training.***

***Fellows and faculty members are at risk for burnout and depression. Programs, in partnership with their Sponsoring Institutions, have the same responsibility to address well-being as other aspects of resident competence. Physicians and all members of the***

*health care team share responsibility for the well-being of each other. A positive culture in a clinical learning environment models constructive behaviors, and prepares fellows with the skills and attitudes needed to thrive throughout their careers.*

**6.13. The responsibility of the program, in partnership with the Sponsoring Institution, must include:**

**6.13.a. attention to scheduling, work intensity, and work compression that impacts fellow well-being; (Core)**

**6.13.b. evaluating workplace safety data and addressing the safety of fellows and faculty members; (Core)**

**Background and Intent:** This requirement emphasizes the responsibility shared by the Sponsoring Institution and its programs to gather information and utilize systems that monitor and enhance fellow and faculty member safety, including physical safety. Issues to be addressed include, but are not limited to, monitoring of workplace injuries, physical or emotional violence, vehicle collisions, and emotional well-being after safety events.

**6.13.c. policies and programs that encourage optimal fellow and faculty member well-being; and, (Core)**

**Background and Intent:** Well-being includes having time away from work to engage with family and friends, as well as to attend to personal needs and to one's own health, including adequate rest, healthy diet, and regular exercise. The intent of this requirement is to ensure that fellows have the opportunity to access medical and dental care, including mental health care, at times that are appropriate to their individual circumstances. Fellows must be provided with time away from the program as needed to access care, including appointments scheduled during their working hours.

**6.13.c.1. Fellows must be given the opportunity to attend medical, mental health, and dental care appointments, including those scheduled during their working hours. (Core)**

**6.13.d. education of fellows and faculty members in:**

**6.13.d.1. identification of the symptoms of burnout, depression, and substance use disorders, suicidal ideation, or potential for violence, including means to assist those who experience these conditions; (Core)**

**6.13.d.2. recognition of these symptoms in themselves and how to seek appropriate care; and, (Core)**

**6.13.d.3. access to appropriate tools for self-screening. (Core)**

**Background and Intent: Programs and Sponsoring Institutions are encouraged to review materials in order to create systems for identification of burnout, depression, and substance use disorder. Materials and more information are available in Learn at ACGME (<https://dl.acgme.org/pages/well-being-tools-resources>).**

**Individuals experiencing burnout, depression, a substance use disorder, and/or suicidal ideation are often reluctant to reach out for help due to the stigma associated with these conditions, and may be concerned that seeking help may have a negative impact on their career. Recognizing that physicians are at increased risk in these areas, it is essential that fellows and faculty members are able to report their concerns when another fellow or faculty member displays signs of any of these conditions, so that the program director or other designated personnel, such as the department chair, may assess the situation and intervene as necessary to facilitate access to appropriate care. Fellows and faculty members must know which personnel, in addition to the program director, have been designated with this responsibility; those personnel and the program director should be familiar with the institution's impaired physician policy and any employee health, employee assistance, and/or wellness/well-being programs within the institution. In cases of physician impairment, the program director or designated personnel should follow the policies of their institution for reporting.**

- 6.13.e. providing access to confidential, affordable mental health assessment, counseling, and treatment, including access to urgent and emergent care 24 hours a day, seven days a week. (Core)**

**Background and Intent: The intent of this requirement is to ensure that fellows have immediate access at all times to a mental health professional (psychiatrist, psychologist, Licensed Clinical Social Worker, Primary Mental Health Nurse Practitioner, or Licensed Professional Counselor) for urgent or emergent mental health issues. In-person, telemedicine, or telephonic means may be utilized to satisfy this requirement. Care in the Emergency Department may be necessary in some cases, but not as the primary or sole means to meet the requirement.**

**The reference to affordable counseling is intended to require that financial cost not be a barrier to obtaining care.**

- 6.14. There are circumstances in which fellows may be unable to attend work, including but not limited to fatigue, illness, family emergencies, and medical, parental, or caregiver leave. Each program must allow an appropriate length of absence for fellows unable to perform their patient care responsibilities. (Core)**
- 6.14.a. The program must have policies and procedures in place to ensure coverage of patient care and ensure continuity of patient care. (Core)**
- 6.14.b. These policies must be implemented without fear of negative consequences for the fellow who is or was unable to provide the clinical work. (Core)**

**Background and Intent:** Fellows may need to extend their length of training depending on length of absence and specialty board eligibility requirements. Teammates should assist colleagues in need and equitably reintegrate them upon return.

**6.15. Fatigue Mitigation**

Programs must educate all fellows and faculty members in recognition of the signs of fatigue and sleep deprivation, alertness management, and fatigue mitigation processes. <sup>(Detail)</sup>

**Background and Intent:** Providing medical care to patients is physically and mentally demanding. Night shifts, even for those who have had enough rest, cause fatigue. Experiencing fatigue in a supervised environment during training prepares fellows for managing fatigue in practice. It is expected that programs adopt fatigue mitigation processes and ensure that there are no negative consequences and/or stigma for using fatigue mitigation strategies.

Strategies that may be used include, but are not limited to, strategic napping; the judicious use of caffeine; availability of other caregivers; time management to maximize sleep off-duty; learning to recognize the signs of fatigue, and self-monitoring performance and/or asking others to monitor performance; remaining active to promote alertness; maintaining a healthy diet; using relaxation techniques to fall asleep; maintaining a consistent sleep routine; exercising regularly; increasing sleep time before and after call; and ensuring sufficient sleep recovery periods.

**6.16. The program, in partnership with its Sponsoring Institution, must ensure adequate sleep facilities and safe transportation options for fellows who may be too fatigued to safely return home. <sup>(Core)</sup>**

**6.17. Clinical Responsibilities**

The clinical responsibilities for each fellow must be based on PGY level, patient safety, fellow ability, severity and complexity of patient illness/condition, and available support services. <sup>(Core)</sup>

**Background and Intent:** The changing clinical care environment of medicine has meant that work compression due to high complexity has increased stress on fellows. Faculty members and program directors need to make sure fellows function in an environment that has safe patient care and a sense of fellow well-being. It is an essential responsibility of the program director to monitor fellow workload. Workload should be distributed among the fellow team and interdisciplinary teams to minimize work compression.

**6.18. Teamwork**

Fellows must care for patients in an environment that maximizes communication and promotes safe, interprofessional, team-based care in the subspecialty and larger health system. <sup>(Core)</sup>

**Background and Intent: Effective programs will have a structure that promotes safe, interprofessional, team-based care. Optimal patient safety occurs in the setting of a coordinated interprofessional learning and working environment.**

6.18.a. The program must provide educational experiences that allow fellows to interact with and learn from other health care professionals, such as physicians in other specialties, advanced practice providers, nurses, social workers, physical therapists, case managers, language interpreters, and dieticians, in order to achieve effective, interdisciplinary, and interprofessional team-based care. (Core)

**6.19. Transitions of Care**

**Programs must design clinical assignments to optimize transitions in patient care, including their safety, frequency, and structure. (Core)**

6.19.a. Programs, in partnership with their Sponsoring Institutions, must ensure and monitor effective, structured hand-off processes to facilitate both continuity of care and patient safety. (Core)

6.19.b. Programs must ensure that fellows are competent in communicating with team members in the hand-off process. (Outcome)

**Clinical Experience and Education**

***Programs, in partnership with their Sponsoring Institutions, must design an effective program structure that is configured to provide fellows with educational and clinical experience opportunities, as well as reasonable opportunities for rest and personal activities.***

**Background and Intent: The terms “clinical experience and education,” “clinical and educational work,” and “clinical and educational work hours” replace the terms “duty hours,” “duty periods,” and “duty.” These terms are used in response to concerns that the previous use of the term “duty” in reference to number of hours worked may have led some to conclude that fellows’ duty to “clock out” on time superseded their duty to their patients.**

**6.20. Maximum Hours of Clinical and Educational Work per Week**

**Clinical and educational work hours must be limited to no more than 80 hours per week, averaged over a four-week period, inclusive of all in-house clinical and educational activities, clinical work done from home, and all moonlighting. (Core)**

**Background and Intent: Programs and fellows have a shared responsibility to ensure that the 80-hour maximum weekly limit is not exceeded. While the requirement has been written with the intent of allowing fellows to remain beyond their scheduled work periods to care for a patient or participate in an educational activity, these additional hours must be accounted for in the allocated 80 hours when averaged over four weeks.**



### ***Work from Home***

While the requirement specifies that clinical work done from home must be counted toward the 80-hour maximum weekly limit, the expectation remains that scheduling be structured so that fellows are able to complete most work on site during scheduled clinical work hours without requiring them to take work home. The requirements acknowledge the changing landscape of medicine, including electronic health records, and the resulting increase in the amount of work fellows choose to do from home. The requirement provides flexibility for fellows to do this while ensuring that the time spent by fellows completing clinical work from home is accomplished within the 80-hour weekly maximum. Types of work from home that must be counted include using an electronic health record and taking calls from home. Reading done in preparation for the following day's cases, studying, and research done from home do not count toward the 80 hours. Fellow decisions to leave the hospital before their clinical work has been completed and to finish that work later from home should be made in consultation with the fellow's supervisor. In such circumstances, fellows should be mindful of their professional responsibility to complete work in a timely manner and to maintain patient confidentiality.

Fellows are to track the time they spend on clinical work from home and to report that time to the program. Decisions regarding whether to report infrequent phone calls of very short duration will be left to the individual fellow. Programs will need to factor in time fellows are spending on clinical work at home when schedules are developed to ensure that fellows are not working in excess of 80 hours per week, averaged over four weeks. There is no requirement that programs assume responsibility for documenting this time. Rather, the program's responsibility is ensuring that fellows report their time from home and that schedules are structured to ensure that fellows are not working in excess of 80 hours per week, averaged over four weeks.

#### **6.21. Mandatory Time Free of Clinical Work and Education**

**Fellows should have eight hours off between scheduled clinical work and education periods. (Detail)**

**Background and Intent:** There may be circumstances when fellows choose to stay to care for their patients or return to the hospital with fewer than eight hours free of clinical experience and education. This occurs within the context of the 80-hour and the one-day-off-in-seven requirements. While it is expected that fellow schedules will be structured to ensure that fellows are provided with a minimum of eight hours off between scheduled work periods, it is recognized that fellows may choose to remain beyond their scheduled time, or return to the clinical site during this time-off period, to care for a patient. The requirement preserves the flexibility for fellows to make those choices. It is also noted that the 80-hour weekly limit (averaged over four weeks) is a deterrent for scheduling fewer than eight hours off between clinical and education work periods, as it would be difficult for a program to design a schedule that provides fewer than eight hours off without violating the 80-hour rule.

- 6.21.a. Fellows must have at least 14 hours free of clinical work and education after 24 hours of in-house call. (Core)**

**Background and Intent: Fellows have a responsibility to return to work rested, and thus are expected to use this time away from work to get adequate rest. In support of this goal, fellows are encouraged to prioritize sleep over other discretionary activities.**

- 6.21.b. Fellows must be scheduled for a minimum of one day in seven free of clinical work and required education (when averaged over four weeks). At-home call cannot be assigned on these free days. (Core)**

**Background and Intent: The requirement provides flexibility for programs to distribute days off in a manner that meets program and fellow needs. It is strongly recommended that fellows' preference regarding how their days off are distributed be considered as schedules are developed. It is desirable that days off be distributed throughout the month, but some fellows may prefer to group their days off to have a "golden weekend," meaning a consecutive Saturday and Sunday free from work. The requirement for one free day in seven should not be interpreted as precluding a golden weekend. Where feasible, schedules may be designed to provide fellows with a weekend, or two consecutive days, free of work. The applicable Review Committee will evaluate the number of consecutive days of work and determine whether they meet educational objectives. Programs are encouraged to distribute days off in a fashion that optimizes fellow well-being, and educational and personal goals. It is noted that a day off is defined in the ACGME Glossary of Terms as "one (1) continuous 24-hour period free from all administrative, clinical, and educational activities."**

**6.22. Maximum Clinical Work and Education Period Length**

**Clinical and educational work periods for fellows must not exceed 24 hours of continuous scheduled clinical assignments. (Core)**

- 6.22.a. Up to four hours of additional time may be used for activities related to patient safety, such as providing effective transitions of care, and/or fellow education. Additional patient care responsibilities must not be assigned to a fellow during this time. (Core)**

**Background and Intent: The additional time referenced in 6.22.a. should not be used for the care of new patients. It is essential that the fellow continue to function as a member of the team in an environment where other members of the team can assess fellow fatigue, and that supervision for post-call fellows is provided. This 24 hours and up to an additional four hours must occur within the context of 80-hour weekly limit, averaged over four weeks.**

**6.23. Clinical and Educational Work Hour Exceptions**

**In rare circumstances, after handing off all other responsibilities, a fellow, on their own initiative, may elect to remain or return to the clinical site in the following circumstances: to continue to provide care to a single severely ill or unstable**

patient; to give humanistic attention to the needs of a patient or patient's family; or to attend unique educational events. (Detail)

- 6.23.a. These additional hours of care or education must be counted toward the 80-hour weekly limit. (Detail)

**Background and Intent:** This requirement is intended to provide fellows with some control over their schedules by providing the flexibility to voluntarily remain beyond the scheduled responsibilities under the circumstances described above. It is important to note that a fellow may remain to attend a conference, or return for a conference later in the day, only if the decision is made voluntarily. Fellows must not be required to stay. Programs allowing fellows to remain or return beyond the scheduled work and clinical education period must ensure that the decision to remain is initiated by the fellow and that fellows are not coerced. This additional time must be counted toward the 80-hour maximum weekly limit.

- 6.24. A Review Committee may grant rotation-specific exceptions for up to 10 percent or a maximum of 88 clinical and educational work hours to individual programs based on a sound educational rationale.

The Review Committee for Internal Medicine will not consider requests for exceptions to the 80-hour limit to the fellows' work week.

- 6.25. **Moonlighting**  
Moonlighting must not interfere with the ability of the fellow to achieve the goals and objectives of the educational program, and must not interfere with the fellow's fitness for work nor compromise patient safety. (Core)

- 6.25.a. Time spent by fellows in internal and external moonlighting (as defined in the ACGME Glossary of Terms) must be counted toward the 80-hour maximum weekly limit. (Core)

**Background and Intent:** For additional clarification of the expectations related to moonlighting, please refer to the Common Program Requirement FAQs (available at <http://www.acgme.org/What-We-Do/Accreditation/Common-Program-Requirements>).

- 6.26. **In-House Night Float**  
Night float must occur within the context of the 80-hour and one-day-off-in-seven requirements. (Core)

- 6.27. **Maximum In-House On-Call Frequency**  
Fellows must be scheduled for in-house call no more frequently than every third night (when averaged over a four-week period). (Core)

- 6.28. **At-Home Call**  
Time spent on patient care activities by fellows on at-home call must count toward the 80-hour maximum weekly limit. The frequency of at-home call is not subject

to the every-third-night limitation, but must satisfy the requirement for one day in seven free of clinical work and education, when averaged over four weeks. (Core)

- 6.28.a. At-home call must not be so frequent or taxing as to preclude rest or reasonable personal time for each fellow. (Core)

**Background and Intent:** As noted in 6.20., clinical work done from home when a fellow is taking at-home call must count toward the 80-hour maximum weekly limit. This acknowledges the often significant amount of time fellows devote to clinical activities when taking at-home call, and ensures that taking at-home call does not result in fellows routinely working more than 80 hours per week. At-home call activities that must be counted include responding to phone calls and other forms of communication, as well as documentation, such as entering notes in an electronic health record. Activities such as reading about the next day's case, studying, or research activities do not count toward the 80-hour weekly limit.

In their evaluation of fellowship programs, Review Committees will look at the overall impact of at-home call on fellow rest and personal time.
